State Geothermal Resources Lease PRC 5217.2 was issued to the surface owners Edward V. Prati, John T. Sink, Peter H. Flood and Richard J. Wall, as rustee, on February 25, 1977. The parcel was offered for lease by competitive bid tha net profits bid factor. The high bid of 47.77% was submitted by George P. Post. The bid was matched by surface owners. Aminoil has entered into a lease with the surface owners with respect to the surface owner's interests, if any, in the geothermal resources. Under this lease Aminoil has been granted whatever rights the surface owner may have to develop the geothermal resources including assignment of the State Lease to Aminoil. In the interim, Aminoil has acted as operator on behalf of the Lessee and now proposed to drill a well within the lease area to evaluate the geothermal potential of the parcel.

Section 36, of the lease, provides that the lessee may assign the lease subject to the written prior consent of the Commission.

The proposed assignent will not have an environmental impact and is considered to be a ministerial project under the Guidelines for Implementation of the California Environmental Quality Act (Title 14, Cal. Adm. Code). An environmental impact report was prepared by the Sonoma County Board of Zoning Adjustments covering geothermal development in the area and was considered by the Commission prior to issuing the lease.
