AREA, TYPE LAND AND LOCATION:  
A 6.10+ acre parcel of State school land,  
near the Coachella Canal, Imperial County.

LAND USE: Temporary concrete batch plant site.

TERMS OF PROPOSED LEASE:

Initial period: 1 year from March 1,  
1980.

Surety bond: \$1,000.

Public liability insurance: Combined single  
limit coverage of \$500,000.

CONSIDERATION: \$550 per annum.

BASIS FOR CONSIDERATION:

\$550 minimum rental for this type of lease.

PREREQUISITE TERMS, FEES AND EXPENSES:

Filing fee has been received.

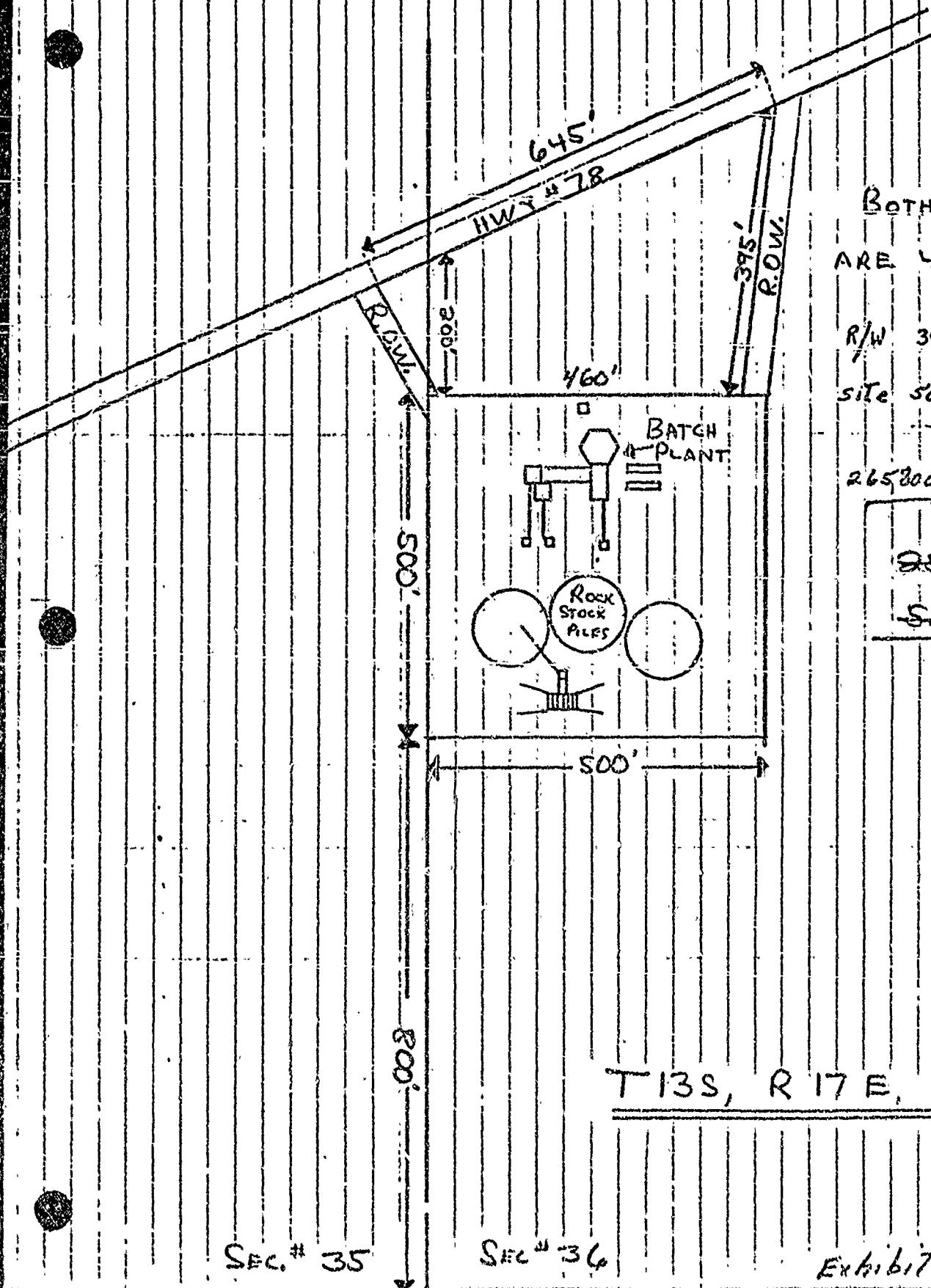

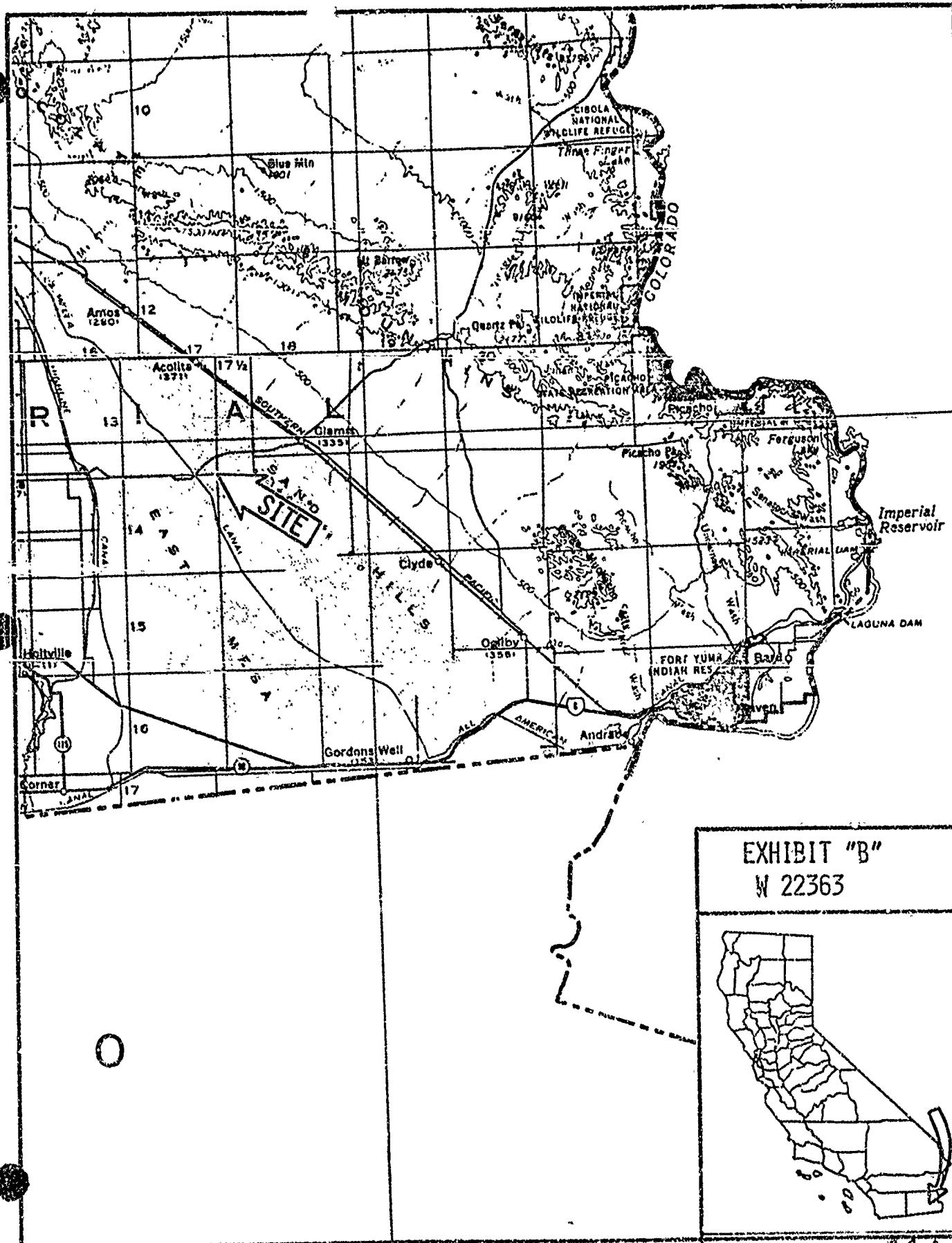
