SUMMARY OF PROPOSAL:

The California and Hawaiian Sugar Company and Crockett Marine Service, Inc., seek to revise their present sublease arrangement. The current 4.97 acres which Crockett Marine now uses will be expanded to 10 acres.

The California and Hawaiian Sugar Company will continue to pay \$3,330 per annum to the State of California as required in Lease PRC 2546.1, and will continue to stand as Master Lessee until the lease is terminated. This 25 year lease commenced on August 20, 1960 and ends on August 19, 1985. The total acreage of the demised premises of the Master Lease is 11.90 acres.

Prior transactions concerning the subject land are itemized in Parts I through IV below. Part V below concerns the proposed sublease presented now for approval.

COMMENSING at a monument formerly set and marked by the California and Hawaiian Sugar Company as No. 258, but since adopted by the United States Army Engineers as their Harbor Line Monument No. 33, and so marked by them on a brass plate set in the concrete filling of a six inch pipe, and shown on that certain map entitled "Harbor Lines for Carquinez Strait, California", dated June 10, 1924, and marked File 4, Div. 4, Sheet 6, which said Harbor Line Monument and point of commencement is located 435.28 feet North and 254.71 feet East of the corner common to Sections 31 and 32, T3N, R3W, MDM, and Sections 5 and 6, T2N, R3W, MDM, said corner common to said Sections 31, 32, 5 and 6, being marked by a point in a bronze plate set in the top of a concrete pyramid approximately 10 feet high resting on piles driven into the earth, thence N 83°15'30"W 255.96 feet to a point; thence due North 145.66 feet to a point on the United States Bulkhead Line of 1888; thence N 89°03'15"W along the said United States Bulkhead Line of 1888, 536.35 feet to the TRUE POINT OF BEGINNING of this description, said true point of beginning bears 617.44 feet North and 536.28 feet West of the aforesaid Section Corner common to Sections 31, 32, 5 and 6, thence due North 462.81 feet to a point in the waters of Carquinez Strait located on the United States Bulkhead Line as shown on the aforesaid map entitled "Harbor Lines for Carquinez Strait, California"; thence N 87°07'22"W along said United States Bulkhead line 927.73 feet to a point, thence S 1940'W 468.06 feet to a point on the northerly right-of-way line of the Southern Pacific Railroad Company, thence S 83°14'45"E along the said northerly right-of-way line of the Southern Pacific Railroad Company 257.58 feet to a point; thence continuing along said northerly right-of-way line of the Southern Pacific Railroad Company which right-of-way line is also the United States Bulkhead Line of 1888, S 89°03'15"E 684.46 feet more or less to the true point of beginning and containing 10.0 acres of land more or less.
