GENERAL PERMIT - RIGHT OF WAY USE

APPLICANT: Pacific Telephone and Telegraph Company  
3707 Kings Way  
Section C-32  
Sacramento, California 95821

AREA, TYPE LAND AND LOCATION:  
0.09 acre parcel of submerged land in the  
bed of the Yuba River, parallel to the  
Highway 20 Bridge, near Smartville, Yuba  
County.

LAND USE: Construction and maintenance of an overhead  
telephone cable.

TERMS OF PROPOSED PERMIT:  
Special: Continuous use plus 1  
year from August 1, 1980.

BASIS FOR CONSIDERATION:  
Exempt by law, Section 7901, Public Utilities  
Code.

PREREQUISITE TERMS, FEES AND EXPENSES:  
Applicant is permittee of upland.

Filing fee and processing costs have been  
received.

STATUTORY AND OTHER REFERENCES:

2. This project is exempt from CEQA because the project involves the replacement of an existing overhead utility crossing.

Authority: 2 Cal. Adm. Section 2907, Class 3(f).

3. This project is situated on State land identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in a use category, Class B, which authorizes Limited Use.

Staff has coordinated this project with those agencies and organizations who nominated the site as containing significant environmental values. They have found this project to be compatible with their nomination.

1. DETERMINE THAT AN EIR HAS NOT BEEN PREPARED FOR THIS ACTIVITY AS SUCH REPORT IS NOT REQUIRED UNDER THE PROVISIONS OF P.R.C. 21084, 14 CAL. ADM. CODE 15100 ET SEQ., AND 2 CAL. ADM. CODE 2907.
2. FIND THAT GRANTING OF THE PERMIT WILL HAVE NO SIGNIFICANT EFFECT UPON ENVIRONMENTAL CHARACTERISTICS IDENTIFIED PURSUANT TO SECTION 6370.1, OF THE P.R.C.
3. AUTHORIZE ISSUANCE TO PACIFIC TELEPHONE AND TELEGRAPH COMPANY OF A CONTINUOUS USE PLUS 1-YEAR GENERAL PERMIT - RIGHT-OF-WAY USE FROM AUGUST 1, 1980, WHICH IS EXEMPT FROM CONSIDERATION UNDER SECTION 7901, PUBLIC UTILITIES CODE FOR CONSTRUCTION AND MAINTENANCE OF AN OVERHEAD TELEPHONE CABLE ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

EXHIBIT "A"

LAND DESCRIPTION:

W 22426

A strip of land crossing Yuba River, lying in Sections 29 and 30, T15N, R6E, MDM, Yuba County, California, said strip lying 10 feet on each side of the following described center line:

COMMENCING at a point on the center line of Highway 20, also being Station 225+35.00; thence N 82°12'00"E, 45.5 feet to the TRUE POINT OF BEGINNING; thence S 7°48'00"E, 840 feet to the end of the herein described center line.

EXCEPTING THEREFROM any portion of land lying landward of the ordinary high water mark.

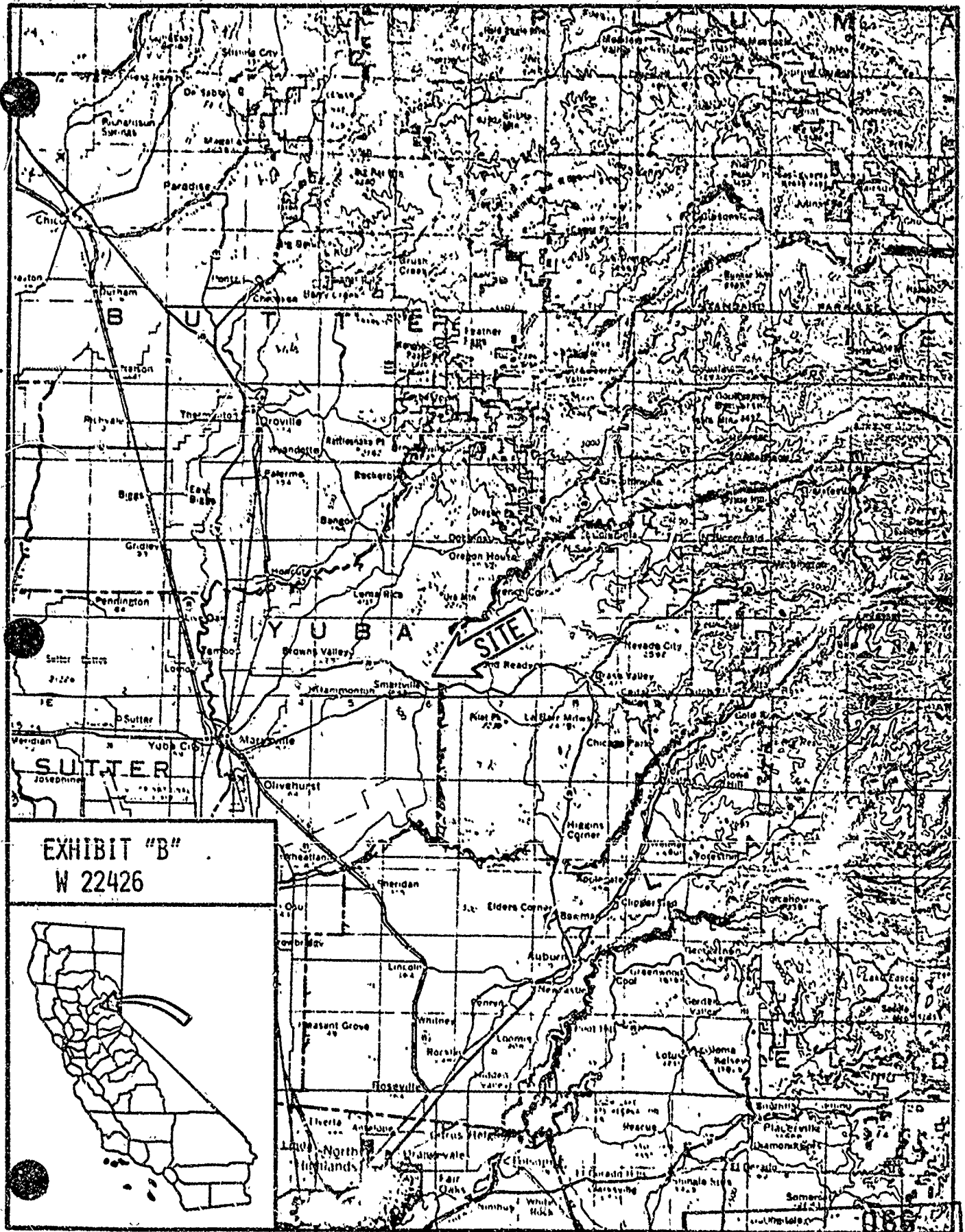
