AMENDMENT OF PUBLIC AGENCY PERMIT

BACKGROUND:

On July 24, 1980, the State Lands Commission authorized issuance to the California Department of Fish and Game of a 49-year General Permit - Public Agency Use from August 1, 1980, in consideration of the public benefit, with the State reserving the right at any time to set a monetary rental if the Commission finds such action to be in the State's best interest. The 2.48-acre parcel is located in the Pacific Ocean, southeast of San Clemente, San Diego County and will be used for an experimental artificial reef to grow giant kelp and abalone.

CURRENT SITUATION:

The Commission's staff has been contacted by the California Department of Fish and Game requesting that the Commission's earlier authorization be amended to provide for a change in the land description of the proposed reef site. The change in location is necessitated by a stipulation in the permit of the San Diego Regional Coastal Commission.

All of the necessary environmental and significant land findings were made during the Commission's action on this project on July 24, 1980 (Minute Item No. 2).

LAND DESCRIPTION

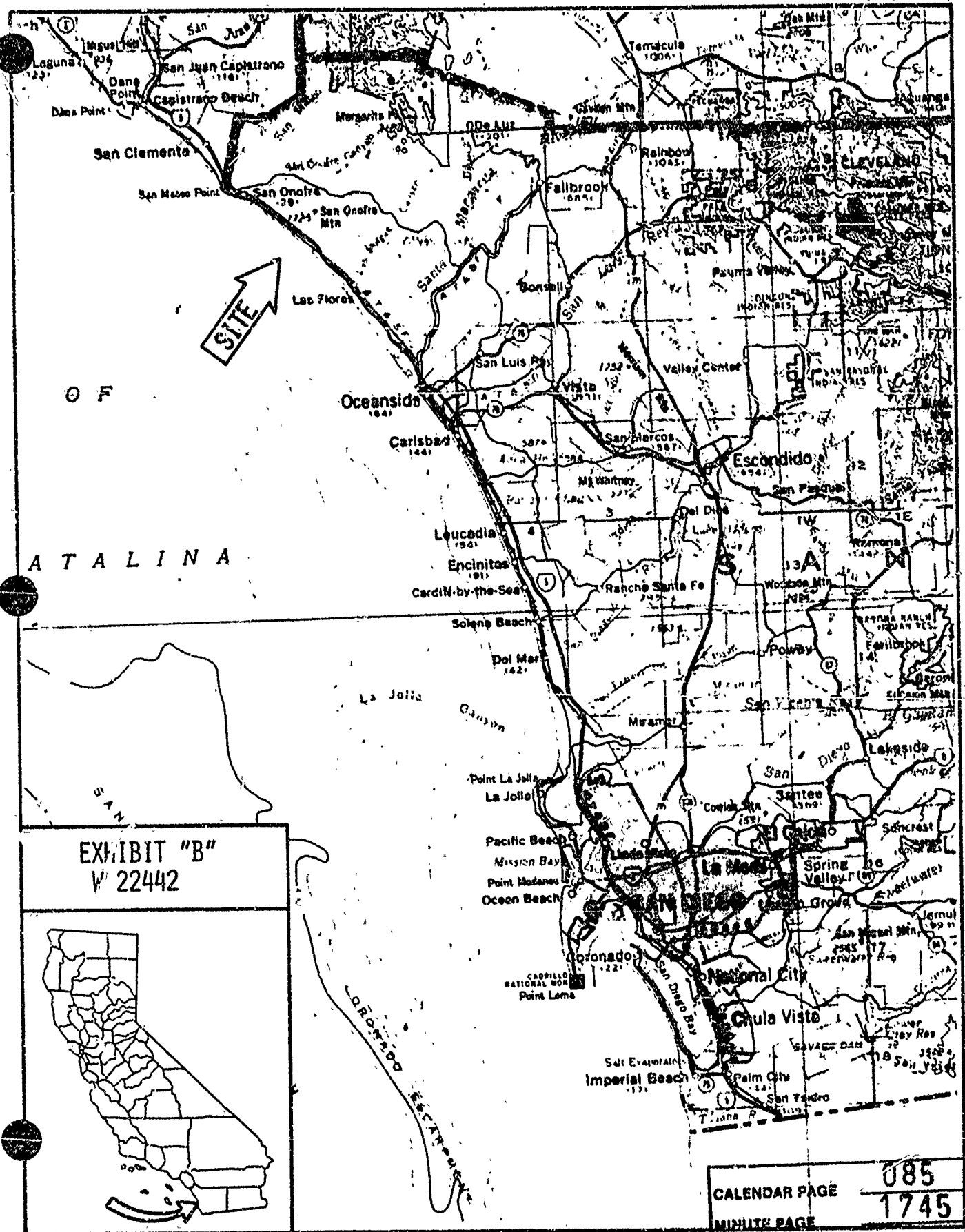

A rectangular parcel of tide and submerged land beneath an artificial reef shown on the exhibit attached to Corps of Engineers Public Notice No. 80-169-NM, Los Angeles District, dated June 9, 1980. The center point of said rectangular parcel being located at  $33^{\circ} 19' 30''$  N  $117^{\circ} 31' 42''$  W, said center point also being identified with California Zone 6 coordinates  $X = 1,609,519.669$ ;  $Y = 423,843.361$ .
