AMENDMENT OF GENERAL PERMIT - PUBLIC AGENCY USE

BACKGROUND:

As referenced in Minute Item No. 26, dated April 24, 1980, the Commission authorized issuance to the United States Department of Agriculture, Forest Service, a 49-year General Permit - Public Agency Use from January 1, 1980, in consideration of the public use and benefit, with the State reserving the right at any time to set a monetary rental if the Commission finds such action to be in the State's best interest; provision of public liability insurance with combined single limit coverage in the amount of \$300,000 for bodily injury and property damage; for maintenance and operation of an existing multiple-use public recreation pier.

CURRENT STATUS:

Pursuant to conditions of the permit and to the extent authorized by Federal law, permittee agrees to indemnify the State of California against any and all claims, loss or liability of any kind which the State may sustain or incur arising out of the issuance of this permit.

With permittee's consent, the provision of public liability insurance requiring combined single limit coverage in the amount of \$300,000 for bodily injury and property damage has been deleted from the authorized agreement. A certificate of insurance will not be required. All other terms and conditions of the permit remain unchanged and in full force and effect.

OTHER PERTINENT INFORMATION:

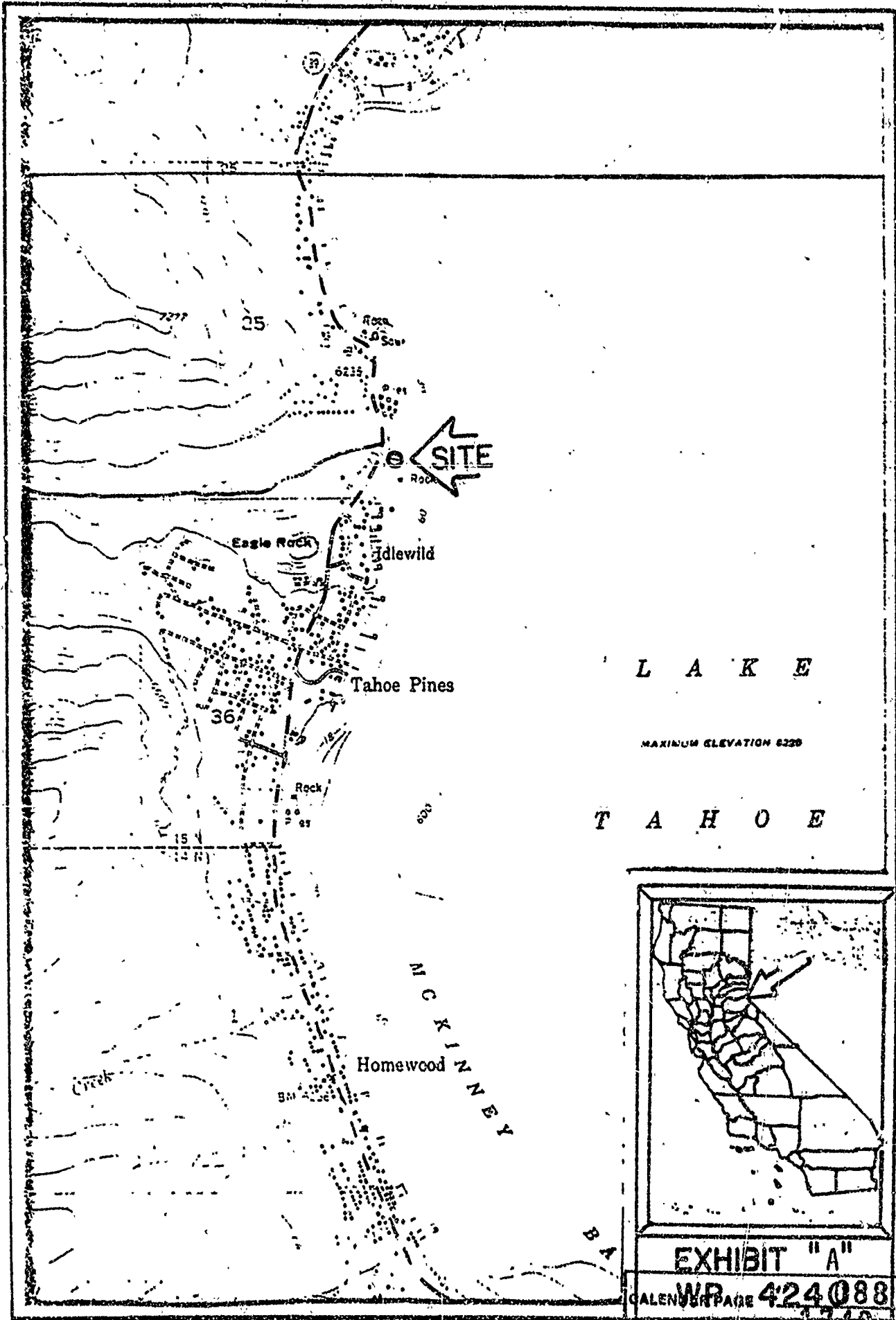
1. This amendment is exempt from CEQA because it is not a project: PRC 21065, 14 Cal. Adm. Code 15037, 15060 and 2 Cal. Adm. Code 2903(d).
2. This project is situated on State land identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in a use category, Class B, which authorizes Limited Use.

Staff review indicates that there will be no significant effect upon the identified environmental values. This is an existing facility for which no adverse comments have been received.

IT IS RECOMMENDED THAT THE COMMISSION:

1. DETERMINE THAT AN EIR HAS NOT BEEN PREPARED FOR THIS ACTIVITY AS SUCH REPORT IS NOT REQUIRED UNDER THE PROVISIONS OF P.R.C. 21065, 14 CAL. ADM. CODE 15037, 15060 AND 2 CAL. ADM. CODE 2903(d).
2. FIND THAT GRANTING THE AMENDMENT OF THE PERMIT WILL HAVE NO SIGNIFICANT EFFECT UPON ENVIRONMENTAL CHARACTERISTICS IDENTIFIED PURSUANT TO SECTION 6370.1 OF P.R.C.
3. AUTHORIZE THE DELETION OF PUBLIC LIABILITY INSURANCE COVERAGE IN THE AMOUNT OF \$300,000 FOR BODILY INJURY AND PROPERTY DAMAGE FROM THE PROVISIONS OF THE PERMIT AUTHORIZED APRIL 24, 1980, IN MINUTE ITEM NO. 26 TO THE UNITED STATES DEPARTMENT OF AGRICULTURE, FOREST SERVICE.

T A H O E

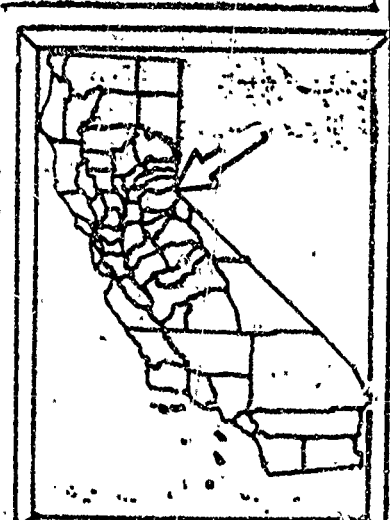
