31. DREDGING PERMIT

During consideration of this item, it was taken off the consent calendar and considered during the regular agenda.

Mr. Peter Dalquist, representing the County of Orange, Environmental Management Agency, appeared. Mr. Dalquist requested that the provision in the permit be deleted whereby the State reserves the right at any time to assess a royal vif the Commission finds such action to be in the State's best interest. However, after discussing this with the applicant, the following language was agreed upon and amended into the Permit:

"The State reserves the right to assess a royalty of 25¢ per cubic yard for material placed on private property or used for any private or commercial property."

Upon motion duly made and carried, the resolution as presented in Calendar Item 31 attached was approved by a vote of 2-0.

SAID PERMIT SHALL BE EFFECTIVE FOR ONE YEAR FROM AUGUST 1, 1980, AND SHALL ALLOW THE DREDGING OF 80,000 CUBIC YARDS OF MINERALS OTHER THAN OIL, GAS AND GEOTHERMAL FROM TIDE AND SUBMERGED LANDS IN THE MOUTH OF SAN JUAN CREEK AND THE PACIFIC OCEAN AT DOHENY BEACH STATE PARK, ORANGE COUNTY. SAID AREA IS DESCRIBED IN EXHIBIT "A" ATTACHED HERETO AND BY REFERENCE EXPRESSLY MADE A PART HEREOF. THE MATERIALS DREDGED SHALL BE DEPOSITED ON THE ADJACENT STATE-OWNED BEACHES.
