OTHER PERTINENT INFORMATION:

1. The annual rental value of the site is estimated to be \$128.
2. A Negative Declaration was prepared by the City of Lodi, pursuant to CEQA and implementing regulations. A Notice of Determination has been received.
3. This project is situated on State land identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in a use category, Class B, which authorizes Limited Use.

Staff has coordinated this project with those agencies and organizations who nominated the site as containing significant environmental values. They have found this project to be compatible with their nomination.

APPROVALS REQUIRED AND OBTAINED:

This facility is subject to the jurisdiction of the United States Army Corps of Engineers, California Department of Fish and Game, California Central Valley Regional Water Quality Control Board, California Reclamation Board, County of San Joaquin and the City of Lodi. The proposed permit is conditioned on the approval of all agencies having jurisdiction.

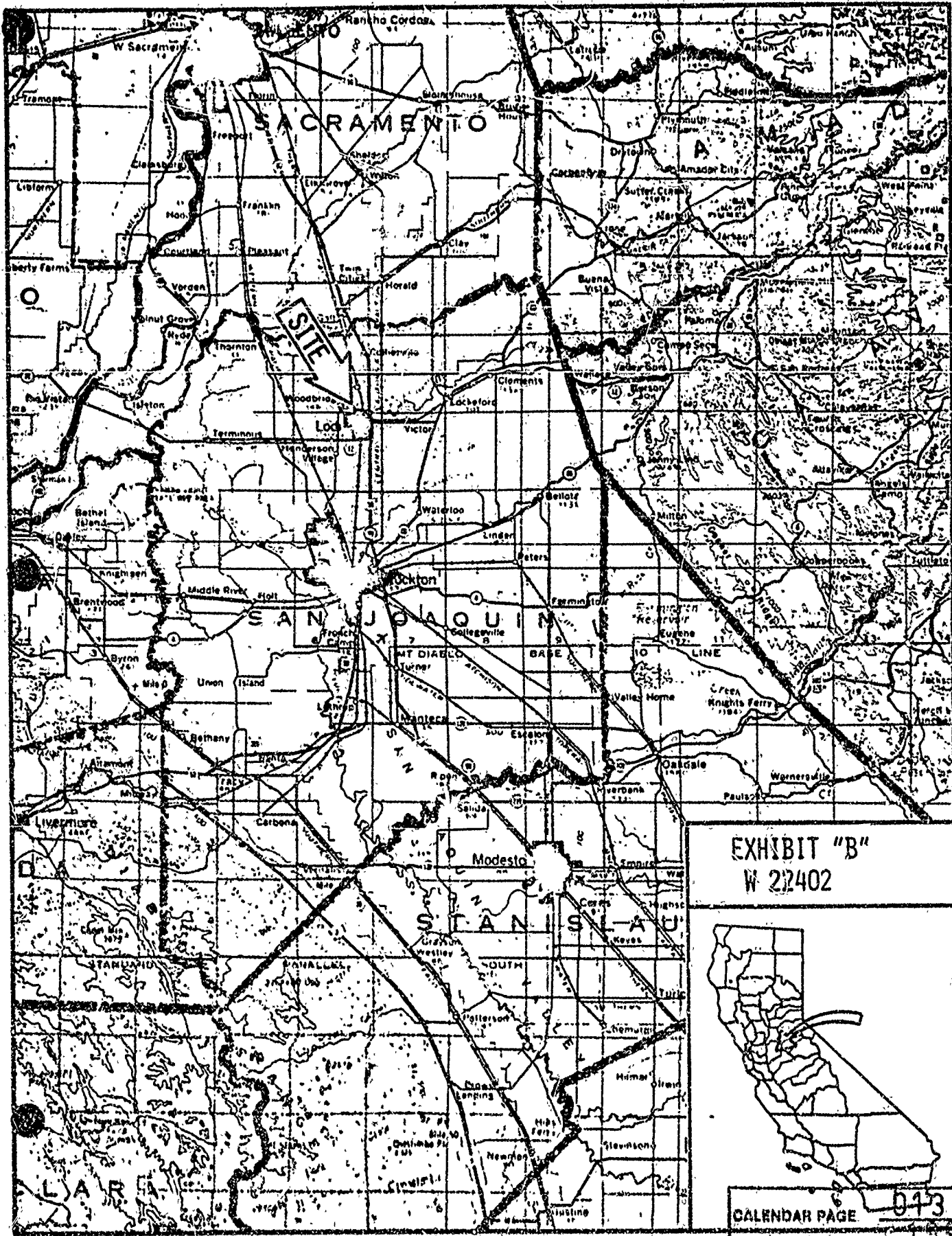

Adverse impacts of project and their magnitude: Construction activities

Mitigation measures offered by developers to reduce adverse impacts: Construction activity will be short-term. Equipment will be muffled, etc., to comply with State and local emission standards. All standard safety precautions to be taken and work to be done only during daylight hours.

Compatibility of project with existing or proposed General Plan, zoning or land uses: Will implement policies and facilitate development in this planned area.

Accept Negative Declaration on the following basis: Identified impacts are comparatively insignificant and short-term. Mitigation measures will be implemented. Future development of the area is a positive impact.
