**AUTHORIZATION FOR REMOVAL OF STRUCTURES  
AND THE RELOCATION AND PRESERVATION OF THE  
CRESCENT SCHOOL ON GRIZZLY ISLAND, SOLANO COUNTY**

**BACKGROUND:**

The State Water Resources Control Board, in Decision 1485, dated August 18, 1978, decreed that the Federal Government and Department of Water Resources must take action to protect the quality of water in the Suisun Marsh. One of the features to be built in conjunction with the Suisun Marsh Facilities is the Grizzly Island Distribution System. On April 28, 1977, the State Lands Commission authorized the issuance of a General Permit - Public Agency Use of 148+ acres of sovereign land in Suisun Marsh, Solano County, for wildlife management and protection, public recreation, or other like purposes consistent with the public trust to the State Department of Fish and Game.

**CURRENT SITUATION:**

The State Departments of Fish and Game and Water Resources in conjunction with the Suisun Marsh Grizzly Island Distribution System have requested permission to remove two deteriorated structures and the relocation and preservation of the Crescent School which is a Historical Solano Landmark.

This project is exempt from CEQA because it is an action by a Regulatory Agency for protection of natural resources and the environment.


