AUTHORIZATION TO FILE DISCLAIMERS
IN THE FOLLOWING ACTIONS
FILED IN THE UNITED STATES DISTRICT COURT
EASTERN DISTRICT
AND INVOLVING LANDS IN STANISLAUS COUNTY

The State of California has been named and served in four condemnation actions filed in United States District Court, Eastern District of California, and entitled United States of America v. 30.82 Acres of Land, et al., Civil No. 294 MDC; United States of America v. 67.64 Acres of Land, et al., Civil No. 299 EDP; United States of America v. 19.53 Acres of Land, et al., Civil No. 300 MDC; United States of America v. 81.85 Acres of Land, et al., Civil No. 295 EDP. Each of the actions involves taking of an easement for a crash safety zone for the Naval Auxiliary Landing Field at Crows Landing, near Patterson, Stanislaus County.

It has been ascertained, after examination and analysis of pertinent Commission records, that there is no present compensable ownership interest held by the State Lands Commission in the parcels subject to these actions. It is therefore recommended that the Commission authorize the Attorney General to file disclaimers on behalf of the Commission, and the Commission only, disclaiming any compensable right, title or interest in the subject parcels.

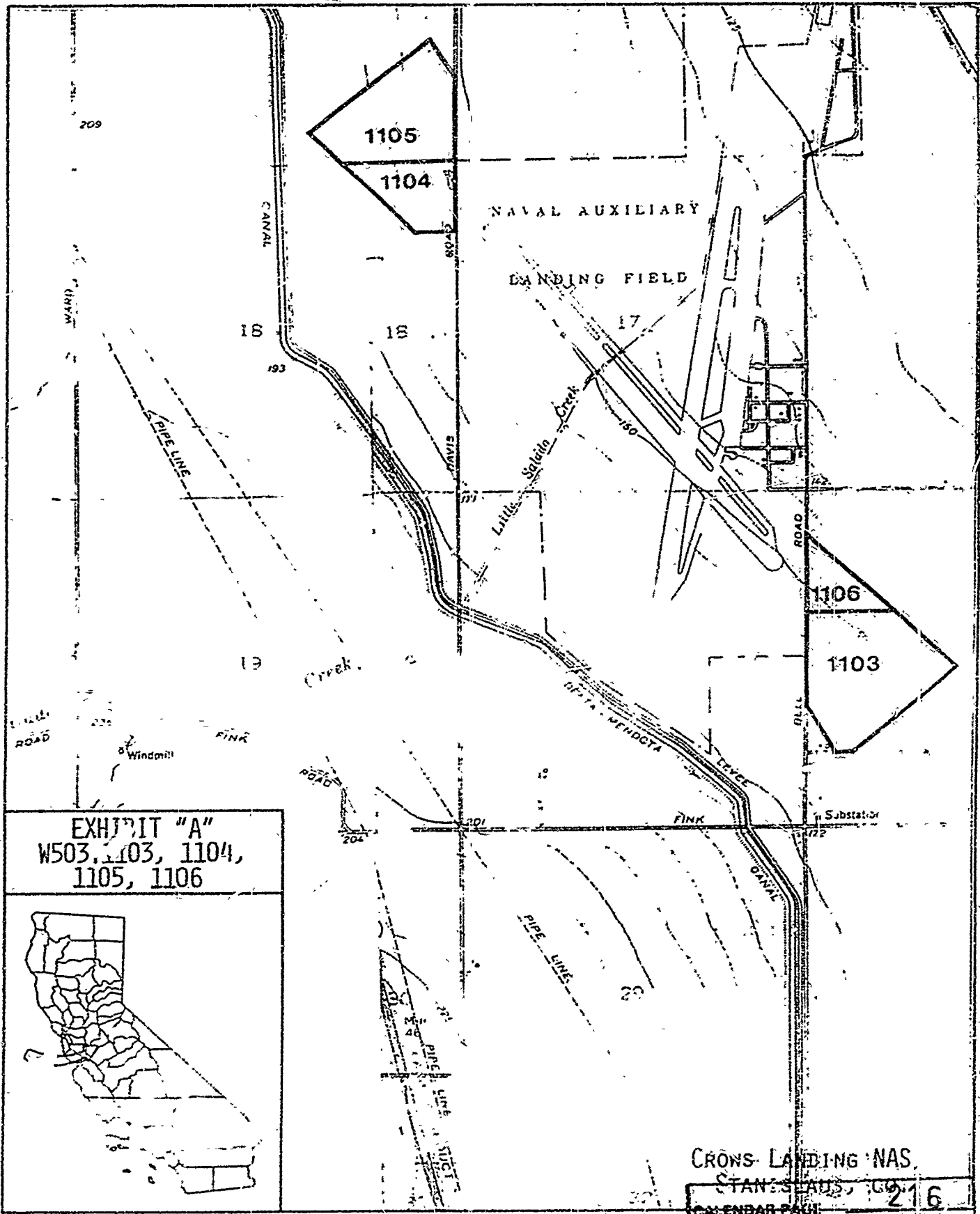
