CABLECOM-GENERAL OF MODESTO

BEGINNING MARCH 16, 1981, CABLECOM-GENERAL OF MODESTO (CABLECOM) PROPOSES TO INSTALL ON EXISTING UPLAND PACIFIC TELEPHONE POLES AN OVERHEAD TELEVISION TRANSMISSION CABLE ACROSS THE TUOLUMNE RIVER AT MODESTO, STANISLAUS COUNTY.

THIS CROSSING IS A NECESSARY PART OF CABLECOM'S PROJECT TO EXTEND TELEVISION CABLE SERVICE TO SOUTH MODESTO. THE BOARD OF SUPERVISORS OF THE COUNTY OF STANISLAUS HAS PASSED A RESOLUTION URGING ALL GOVERNMENTAL AGENCIES WITH JURISDICTION TO EXPEDITE THEIR INVESTIGATIONS AND DETERMINATIONS OF CABLECOM'S PROJECT. ASSEMBLYMAN JOHN E. THURMAN, JR. HAS ALSO EXPRESSLY REQUESTED STAFF TO PROCESS CABLECOM'S APPLICATION AS DILIGENTLY AS POSSIBLE.

A NEGATIVE DECLARATION HAS BEEN PREPARED BY THE BOARD OF SUPERVISORS OF STANISLAUS COUNTY FOR THE PROJECT. A NOTICE OF

DETERMINATION IS ON FILE IN THE OFFICE OF THE SECRETARY OF RESOURCES. NO NEGATIVE COMMENTS HAVE BEEN RECEIVED BY STAFF FROM AGENCIES WITH JURISDICTION.

WITH THE COMMISSION'S CONSENT, I WILL ISSUE A TEMPORARY RIGHT-OF-ENTRY LETTER AUTHORIZING CABLECOM'S PROJECT. THE TEMPORARY RIGHT-OF-WAY WILL COMMENCE MARCH 16, 1981 AND TERMINATE MAY 15, 1981. STAFF IS CURRENTLY PROCESSING THE CABLECOM LEASE AND THE PERMIT FOR THE TELEPHONE COMPANY, BOTH OF WHICH WILL BE SUBMITTED TO THE COMMISSION AT AN UPCOMING MEETING.

ON FEBRUARY 21, 1981, SOUTHERN CALIFORNIA EDISON FILED AN APPLICATION FOR AN EASEMENT TO CONSTRUCT, OPERATE, AND MAINTAIN ELECTRICAL TRANSMISSION LINES OVER A PARCEL OF STATE SCHOOL LAND NEAR DESERT CENTER, RIVERSIDE COUNTY. IN ADDITION, SCE REQUESTED A TEMPORARY RIGHT-OF-ENTRY TO ENTER THE PROPERTY FOR THE PURPOSE OF TESTING THE SOILS IN THE VICINITY OF THE PROPOSED TOWERS.

THE RIGHT-OF-ENTRY SHALL BE VALID FOR A PERIOD OF 90 DAYS, COMMENCING ON THE DATE THE PROPOSED AGREEMENT IS EXECUTED AND RETURNED TO THE COMMISSION. STAFF IS CURRENTLY PROCESSING A LEASE FOR SCE WHICH WILL BE PRESENTED TO THE COMMISSION AT AN UPCOMING MEETING.
