MINUTES OF THE STATE LANDS COMMISSION
MEETING OF

APRIL 29, 1981

The regular meeting of the State Lands Commission was called to order by Chairman Kenneth Cory, State Controller at 9:35 a.m. in the City Council Chambers, City Hall, 915 I Street, Sacramento. The meeting started at 9:35 a.m. for informational matters only. No votes were recorded until 10:00 a.m., the official time the meeting was noticed.

Also present were Commission-Alternate David Ackerman, representing Lieutenant Governor Mike Curb, Commissioner; and Susanne Morgan, representing Director of Finance Mary Ann Graves, Commissioner.

LETTER OF PERMISSION/PACIFIC GAS AND ELECTRIC COMPANY

PACIFIC GAS AND ELECTRIC COMPANY HAS REQUESTED PERMISSION FROM THE COMMISSION TO INSTALL A 12 KV POWERLINE ACROSS WHISKEY SLOUGH IN SAN JOAQUIN COUNTY TO SERVE AN IRRIGATION PUMP ON MCDONALD ISLAND. THE POWERLINE IS NEEDED IMMEDIATELY IN ORDER TO AVOID A POTENTIAL CROP LOSS IN THIS LOCATION, AND PACIFIC GAS AND ELECTRIC REQUESTS A LETTER OF PERMISSION IN ORDER TO INSTALL THIS POWERLINE. THE COMPANY WILL, AS QUICKLY AS POSSIBLE, APPLY FOR A STANDARD RIGHT-OF-WAY LEASE FOR THIS FACILITY. STAFF REQUESTS THE COMMISSION'S AUTHORIZATION TO ISSUE A LETTER OF PERMISSION FOR THE TEMPORARY INSTALLATION OF THIS POWERLINE PENDING APPLICATION BY PACIFIC GAS AND ELECTRIC COMPANY FOR A FORMAL LEASE.

LETTER OF PERMISSION/CROWLEY MARITIME CORPORATION

CROWLEY MARITIME CORPORATION HAS REQUESTED PERMISSION TO CONSTRUCT AND MAINTAIN A TEMPORARY MOORING FACILITY IN THE SACRAMENTO

RIVER (YOLO COUNTY). THE FACILITY IS TO BE USED IN CONJUNCTION WITH THE OPENING OF THE OLD SACRAMENTO RAILROAD MUSEUM.

IN RESPONSE TO THE APPLICANT'S DESIRE TO HAVE THE FACILITY IN PLACE BY NEXT WEEK, I HAVE ISSUED A LETTER PERMIT AUTHORIZING THE CONSTRUCTION AND MAINTENANCE OF THE FACILITY.

THE APPLICANT HAS AGREED TO OBTAIN A GENERAL LEASE - COMMERCIAL USE AS SOON AS POSSIBLE IN ACCORDANCE WITH COMMISSION RULES AND REGULATIONS. THEY HAVE ALREADY OBTAINED A LETTER OF PERMISSION FROM THE U. S. ARMY CORPS OF ENGINEERS, AND STAFF ASSURES ME THAT THE DEPARTMENT OF FISH AND GAME HAS NO CONCERNS.
