TRANSACTION TYPE:

Public Agency Lease.

APPLICANT:

The State of California Department of Fish and Game 1416 Ninth Street, 12th Floor Sacramento, California 95814

AREA, TYPE LAND AND LOCATION:

An area of present salt marsh and open bay out to 100 feet waterward of the present marsh shoreline located near Point Edith along Suisun Bay near the mouth of Pacheco Creek, Contra Costa County, lying adjacent to and northerly of the area leased to the Department of Fish and Game under Lease

PRC 5714.9.

LAND USE:

Wildlife, flora, habitat and environmental study, management and protection.

TERMS OF ORIGINAL LEASE:

Initial period:

66 years from March 25, 1981.

Consideration:

No monetary consideration required in that the public benefit will accrue from Lessee's management of the leased premises.

Should the Lessee realize any income in excess of that needed to repair, maintain, manage or operate the leased premises, the State reserves the right to establish a reasonable rental based upon such income.

By Minute Item 27 of its regular meeting of March 5, 1981, the Commission authorized a Public Agency Lease (PRC 5714.9) to the California Department of Fish and Game of approximately 696 acres of open space marsh land at Point Edith, along Suisun Bay, Contra Costa County for wildlife habitat purposes. The amendment to said lease will incorporate sovereign marsh and open water land bayward of the leased premises out to 100 feet beyond the present marsh shoreline.
- 2. This original project was exempt from CEQA pursuant to the State's EIR Guidelines, Cal. Adm. Code, Title 14, Division 6, Chapter 3, Article 8, Class 25: Transfers of ownership to conserve open space, Section 15125; and as part of the compromise settlement of title disputes, PRC, Section 6371, exempts title settlements
