In accordance with the Commission's delegation of authority to the Executive Officer for the issuance of dredging permits of 10,000 cubic yards or less, Minute Item No. 32, February 24, 1977, permission was granted to perform dredging on State-owned lands to the following party:

APPLICANT: State Coastal Conservancy  
1212 Broadway, Room 514  
Oakland, California 94612

The permit provides for dredging 5000 cubic yards of material from granted tide and submerged lands in Arcata Bay, Humboldt County. The purpose of the dredging is to obtain fill for restoration of a diked and filled former wetland to a saltwater tidal marsh. Dredged materials will be used on the State-owned marsh area. Consideration for the permit is the public use and benefit; the permit provides for royalty of \$0.25 per cubic yard in the event dredged material is sold or placed on private property. The permit will be effective through June 30, 1983.

EXHIBITS: A. Land Description. B. Location Map.

In compliance with said delegation of authority, it has been determined that the following conditions have been met:

1. The proposed project is categorically exempt from the requirements of CEQA, pursuant to the provisions of Section 15104 of the CEQA Guidelines.
2. Issuance of the permit and the resultant project will have no significant adverse effect on the environment or the environmental characteristics identified pursuant to Section 6370.1 et seq., of the P.R.C.
3. The dredging amount will not exceed 10,000 cubic yards.
4. A charge per cubic yard will be assessed for spoil material that is deposited on private property or otherwise lost to future state benefit.

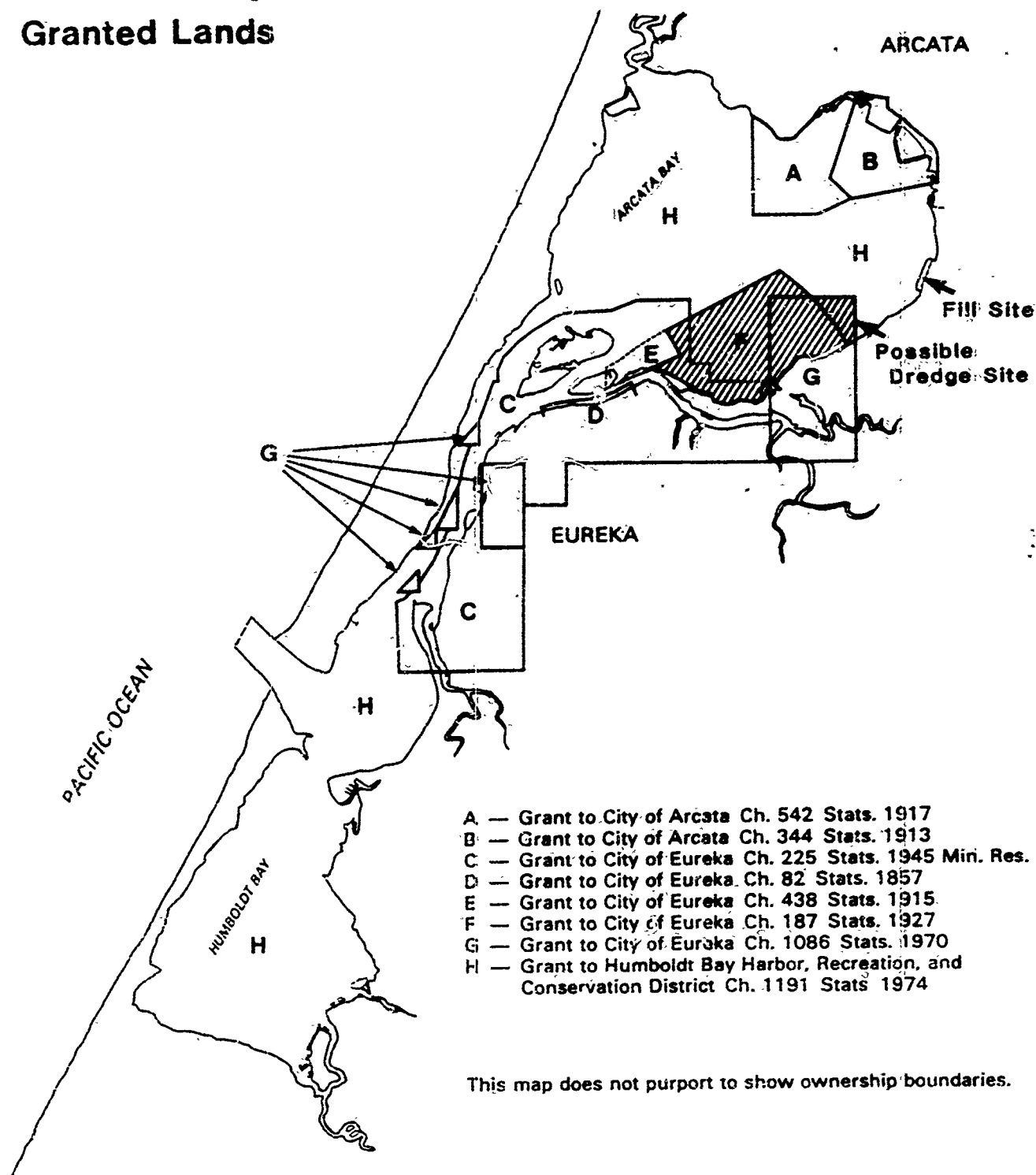

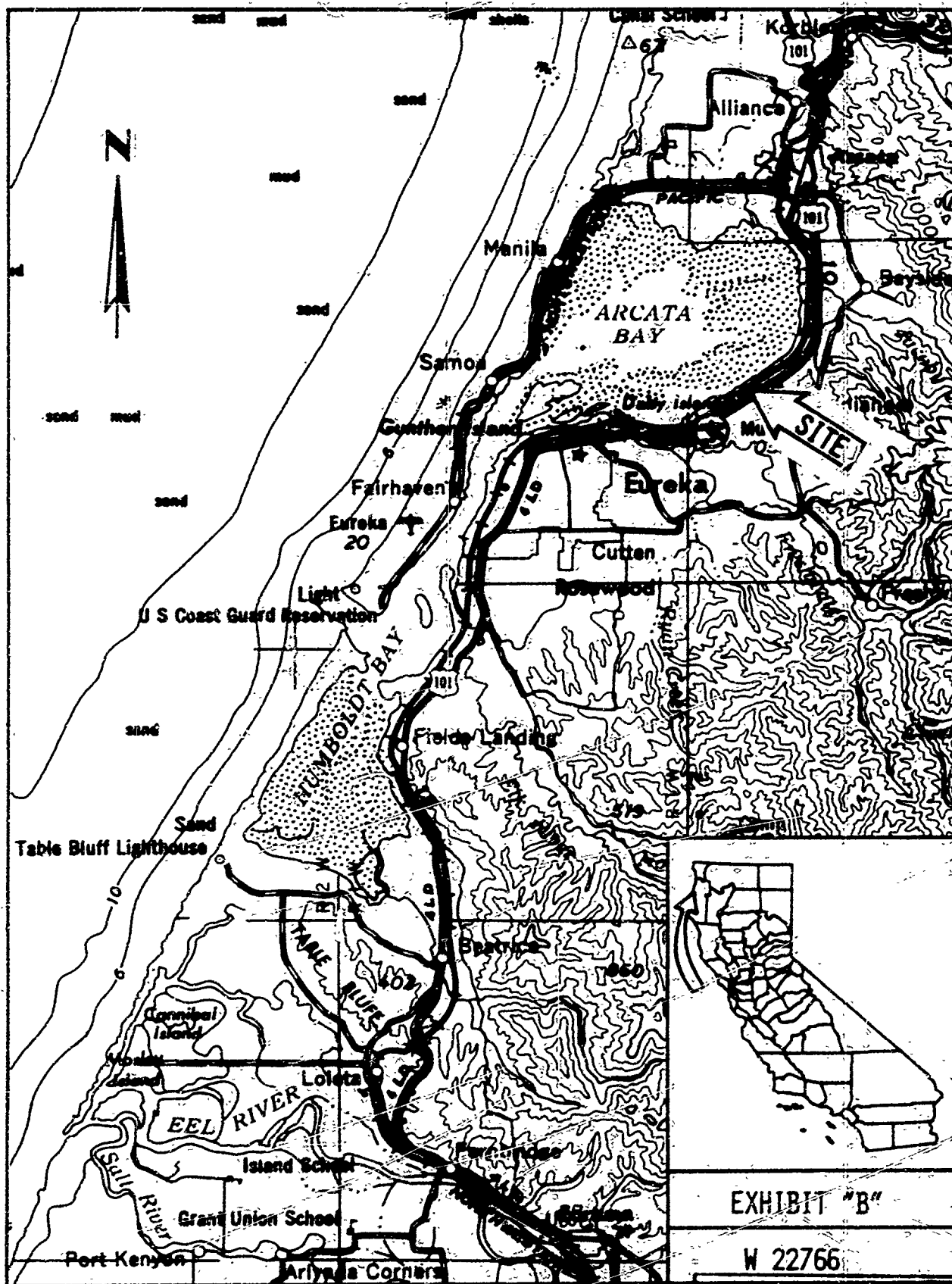
