RESCISSION OF PRIOR AUTHORIZATION OF A COMMERCIAL LEASE AND APPROVAL OF A GENERAL LEASE - COMMERCIAL USE

APPLICANT: Crowley Maritime Corporation One Market Plaza, Suite 3200 San Francisco, California 94611

AREA, TYPE LAND AND LOCATION: 0.33-acre parcel of tide and submerged land in the Sacramento River, Yolo County.

LAND USE: Temporary boat landing.

TERMS OF PROPOSED LEASE:

Initial period: 6 months from May 1, 1981.

Surety bond: \$5,000.

Public liability insurance: Combined single limit coverage of \$500,000.

CONSIDERATION: \$225 for the term of this lease.

Filing fee and \$225 rental fee, Insurance and Bond have been received.



## OTHER PERTINENT INFORMATION:

- 1. On March 31, 1966, the Commission approved as Minute Item No. 18 a lease to Thomas P. Raley for a marina at this site. The lease was never executed by Mr. Raley or the State Lands Commission and the proposed marina was never constructed.
- 2. On April 24, 1981, Mr. William F. Northrop, Executive Officer of the State Lands Commission issued a letter of temporary authorizations to construct and maintain a temporary mooring facility in conjunction with the opening of the Sacramento Railroad Museum. As a condition to the above, the applicant must obtain a General Lease - Commercial Use from the State Lands Commission.
- 3. Staff has been advised by Raley Properties and Crowley Maritime Corporation that in the event that continued use after the opening of the Sacramento Railroad Museum is feasible, permanent facilities will be designed and a long-term lease will be applied for.
- 4. This project is exempt from CEQA because it consists of construction and location of a single new small facility.

Authority: 14 Cal. Adm. Code, Section 15103.

5. This project is situated on State land identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in a use category, Class B, which authorizes Limited Use.

Staff has coordinated this project with those agencies and organizations which nominated the site as containing significant environmental values. They have found this project to be compatible with their nomination.
