AUTHORIZATION TO CONTRACT FOR PREPARATION
OF AN EIR FOR PROPOSED RESUMPTION
OF DRILLING ON STATE OIL AND GAS LEASE PRC 2933.1
SANTA BARBARA CHANNEL, SANTA BARBARA COUNTY

Staff of the State Lands Commission has received an application from Phillips Petroleum Company to resume exploratory activities on an existing State Oil and Gas Lease, PRC 2933.1, located in the Santa Barbara Channel. Phillips proposes to drill a maximum of four exploratory wells. Upon confirmation of the presence of commercially extractable volumes of natural gas, Phillips proposes to begin production after installation of subsea wellheads and flowline systems.

The State Lands Commission is the lead agency for this project under the provisions of the CEQA of 1970, as amended. In this regard, the staff proposes:

- (1) to issue a Request for Proposals for preparation of an EIR,
- (2) to determine the best qualified consultant to prepare such a report, and execute a contract for such services, and
- (3) to provide for the reimbursement by the applicant to the State of staff and consultant costs associated with this environmental analysis.

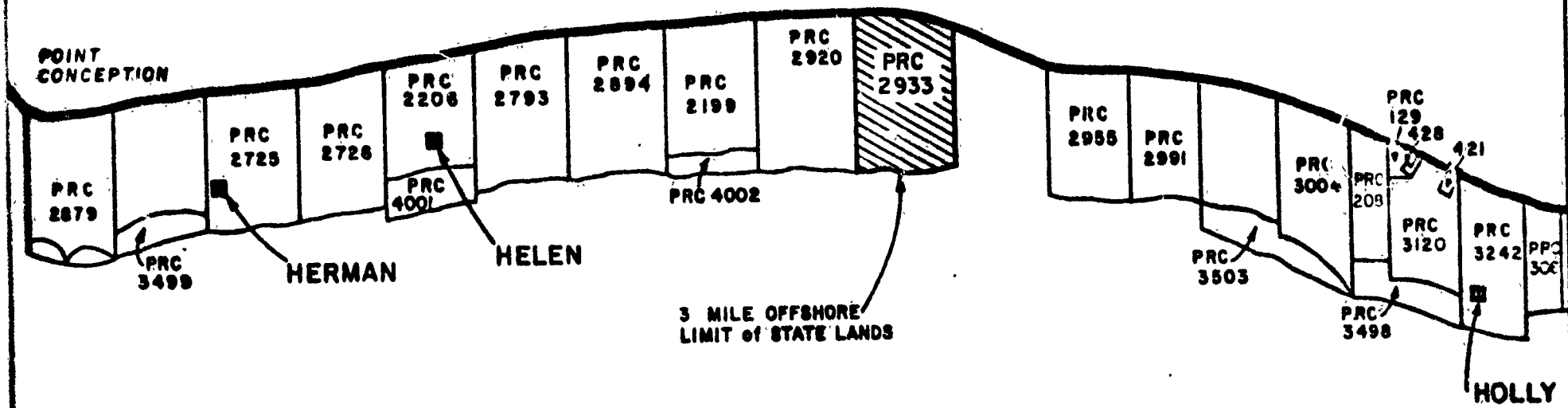
