AMENDMENT OF PROSPECTING PRC 5979
RIVERSIDE COUNTY

APPLICANT: Home Improvement Association, Inc.
Larry Boerner, Agent
8111 Imperial Avenue
Lemon Grove, California 92045

AREA, TYPE LAND AND LOCATION:
School land, 160 acres, N $\frac{1}{2}$ of the N $\frac{1}{2}$ of
Section 16, T6S, R13E, SBBM, Riverside
County. Located 34 miles west of Indio,
one mile south of State Highway 10, in
the vicinity of the Hayfield Pumping Station
and The Hayfield Dry Lake.

SUMMARY: The Permittee, Home Improvement Association,
Larry Boerner, Agent, of prospecting permit
PRC 5979.2 issued on July 1, 1981, has
applied for an amendment to the permit
to allow additional exploration work. Home
Improvement Association proposes excavating
an inclined exploratory shaft following
significant mineralization to determine
if a commercial mineral deposit is present.

TERMS OF AMENDED PERMIT:
Exhibit "A" of Prospecting Permit PRC 5970.2
will be amended to provide that an inclined
exploratory shaft of 60 feet in length
may be located within the permit premises.
All other terms and conditions of this
permit remain unchanged.

2. DETERMINE THAT THE PROJECT WILL NOT HAVE A SIGNIFICANT EFFECT ON THE ENVIRONMENT.
3. APPROVE THE AMENDMENT OF PROSPECTING PERMIT PRC 5979.2 TO PROVIDE EXCAVATION OF AN INCLINED EXPLORATORY SHAFT OF 60 FEET IN LENGTH.

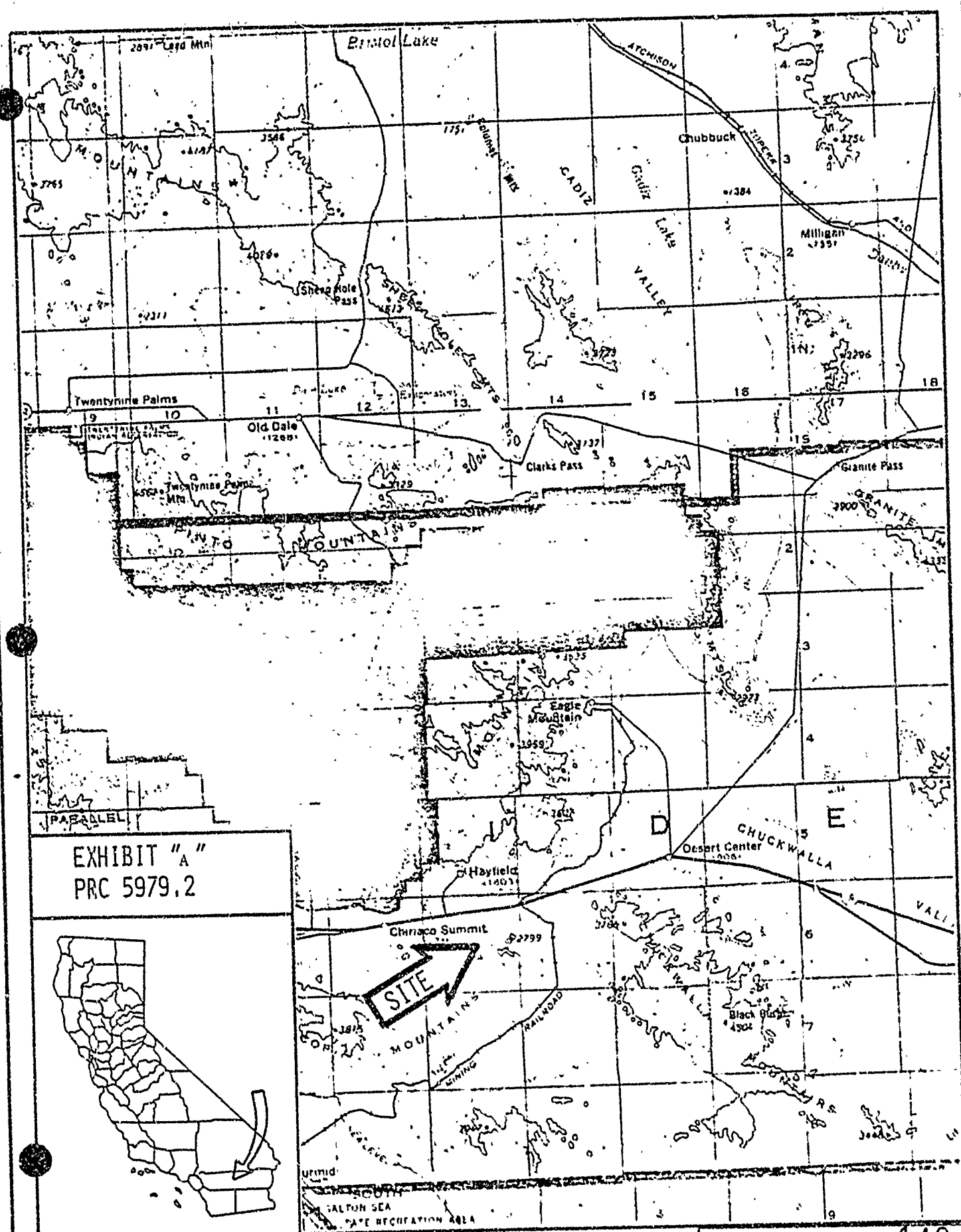
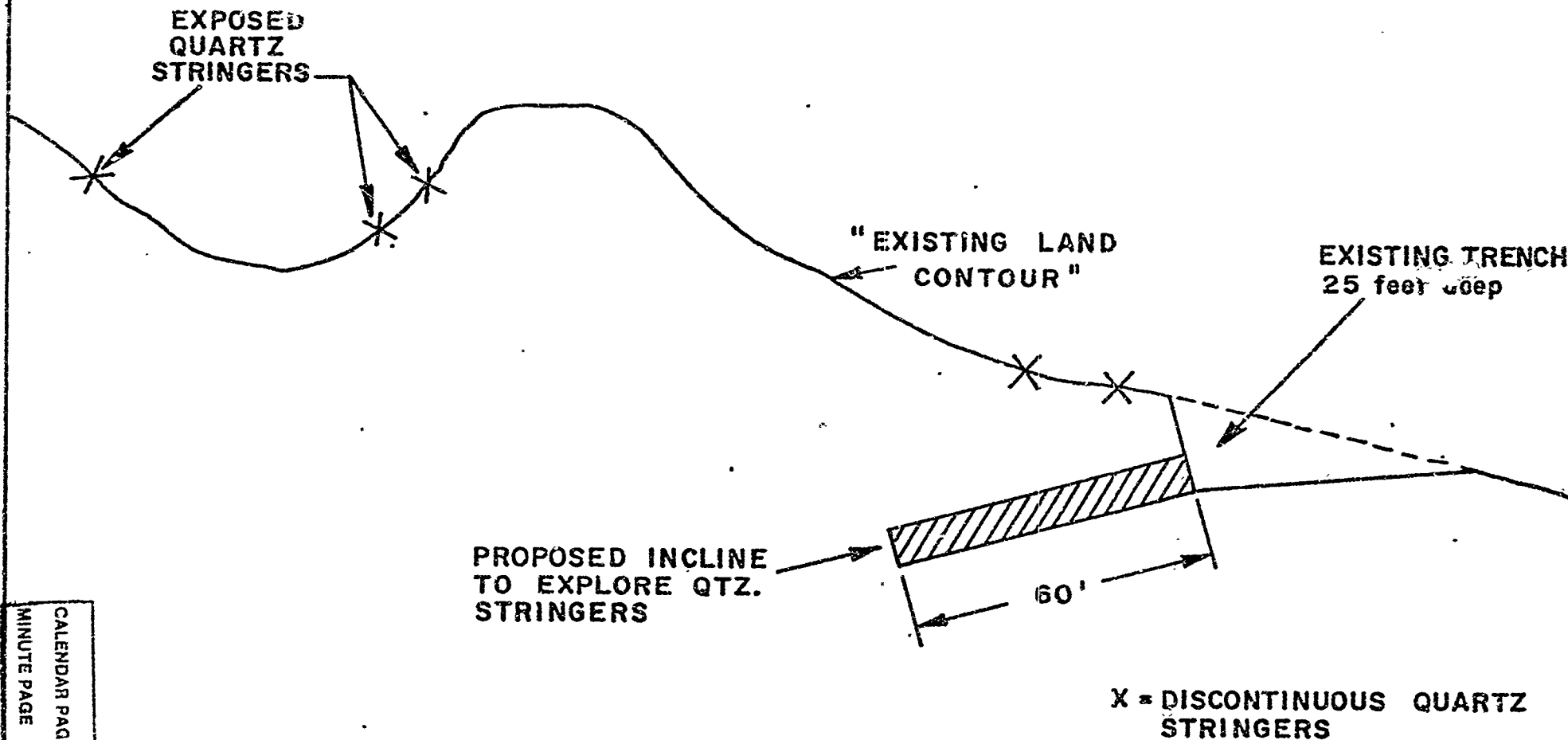


EXHIBIT "A"
