TERMINATION OF RIGHT-OF-WAY LEASE
PRC 3769.1 AND
RECORDATION OF QUITCLAIM DEED

LESSEE: Pacific Gas and Electric Company
P. O. Box 7444
Sacramento, California 95826

AREA, TYPE LAND AND LOCATION:
A 0.195-acre parcel of submerged lands
in the Mokelumne River, near Lockeford,
San Joaquin County.

LAND USE: Installation and maintenance of a 12 KV
pole line utilized to supply electricity
for an irrigation pump.

TERMS OF ORIGINAL LEASE:
Initial period: 15 years from May 25, 1967.
Renewal Options: Three successive periods
of ten years each.
Consideration: \$106.20 for the 15-year
term.

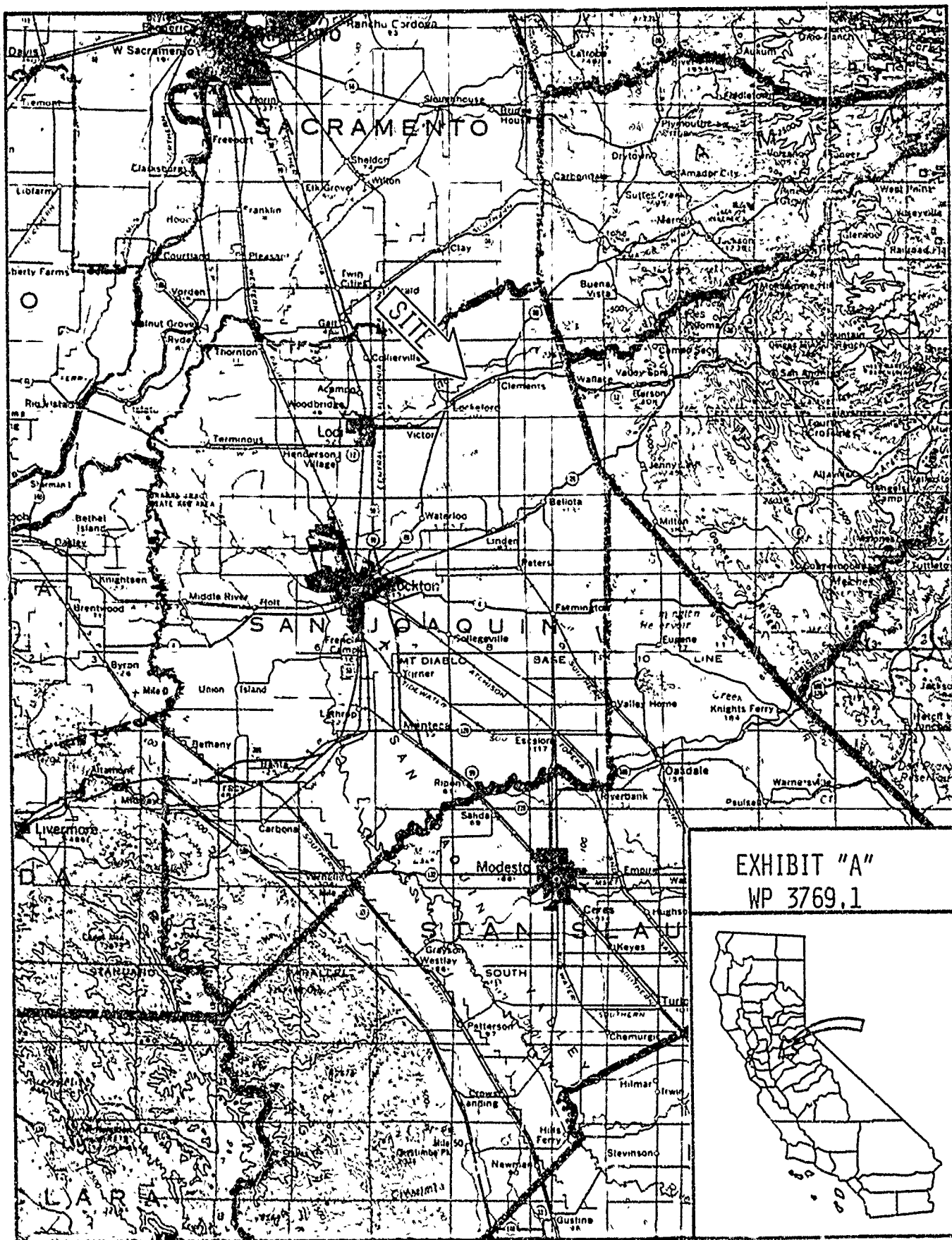
