AUTHORIZATION TO RATIFY  
THE FILING OF A DISCLAIMER REGARDING  
UNITED STATES OF AMERICA V. 9,740 ACRES  
OF LAND, MORE OR LESS, ET AL.,  
UNITED STATES DISTRICT COURT,  
EASTERN DISTRICT OF CALIFORNIA,  
CIVIL NO. S 81-440-RAR, SACRAMENTO COUNTY

The State Lands Commission is a party to a United States condemnation action brought by the United States Attorney entitled, United States of America v. 9,740 Acres of Land, More or Less, etc., et al., filed in the United States District Court, Eastern District of California, Civil No. S 81-440-RAR, involving land in Sacramento County to be used in connection with the proposed Clay Station Reservoir.

An examination of the Commission's records pertinent to the area has revealed no ownership interest held by the State Lands Commission as to the subject tract. The property is crossed by two small intermittent streams, Laguna and Dry Creeks. For that reason, the staff advises the Commission to ratify (as explained below) the filing of a disclaimer in this case as to compensation only.

The District Court issued its final judgment in this case on April 26, 1982. Because of the shift in the State Lands Commission meeting date from April 22 to April 27, the office of the Attorney General filed a disclaimer of compensation in this case before Commission action could be taken. This Calendar Item seeks a ratification of that finding upon the staff's recommendation.

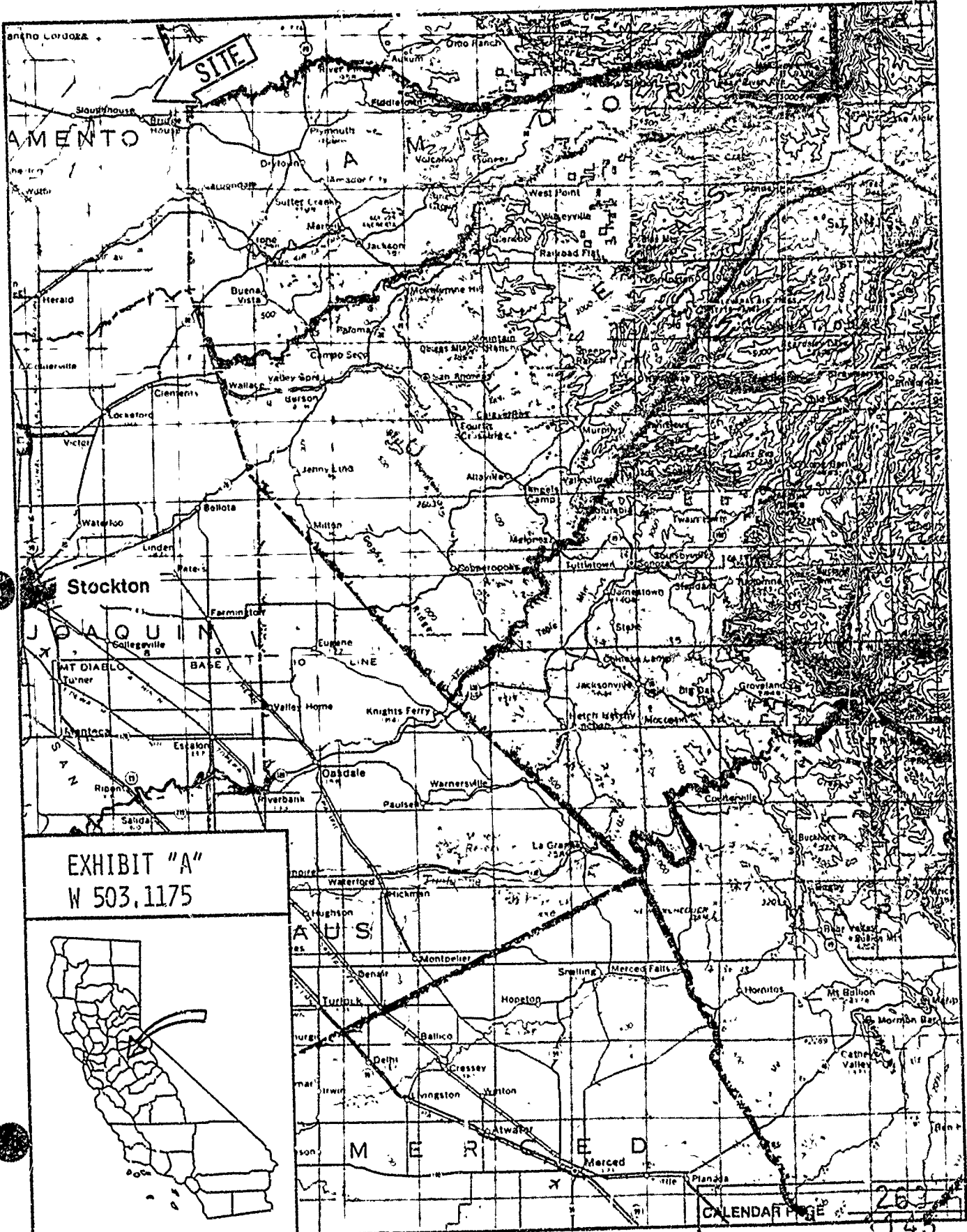
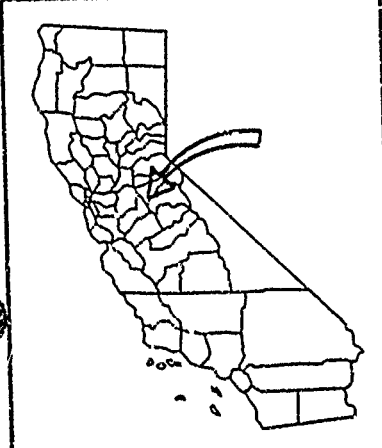
