DREDGING PERMIT

In accordance with the Commission's Delegation of Authority to the Executive Officer for the issuance of dredging permits of 10,000 cubic yards or less, Minute Item 32, February 24, 1977, permission was granted on November 27, 1978 to excavate a maximum of 100 cubic yards of material on State-owned lands to the party named below. Because of requests from private citizens, the applicant has requested modification of the permit, allowing the placing of sufficient material in the mouth of Batiquitos Lagoon, to regulate and maintain a safe and optimum water level for the pumping station.

The modification allows the applicant to replace material in the mouth of Batiquitos Lagoon to keep the lagoon from completely emptying. This modification specifies that all other terms, conditions and requirements of the original permit remain in full force and effect, and requires compliance with the permits, recommendations and limitations of all applicable federal, State and local agencies. The original permit allowed removal of 100 cubic yards of material from State lands at the mouth of Batiquitos Lagoon, north of Leucadia, to permit full emptying of the lagoon.

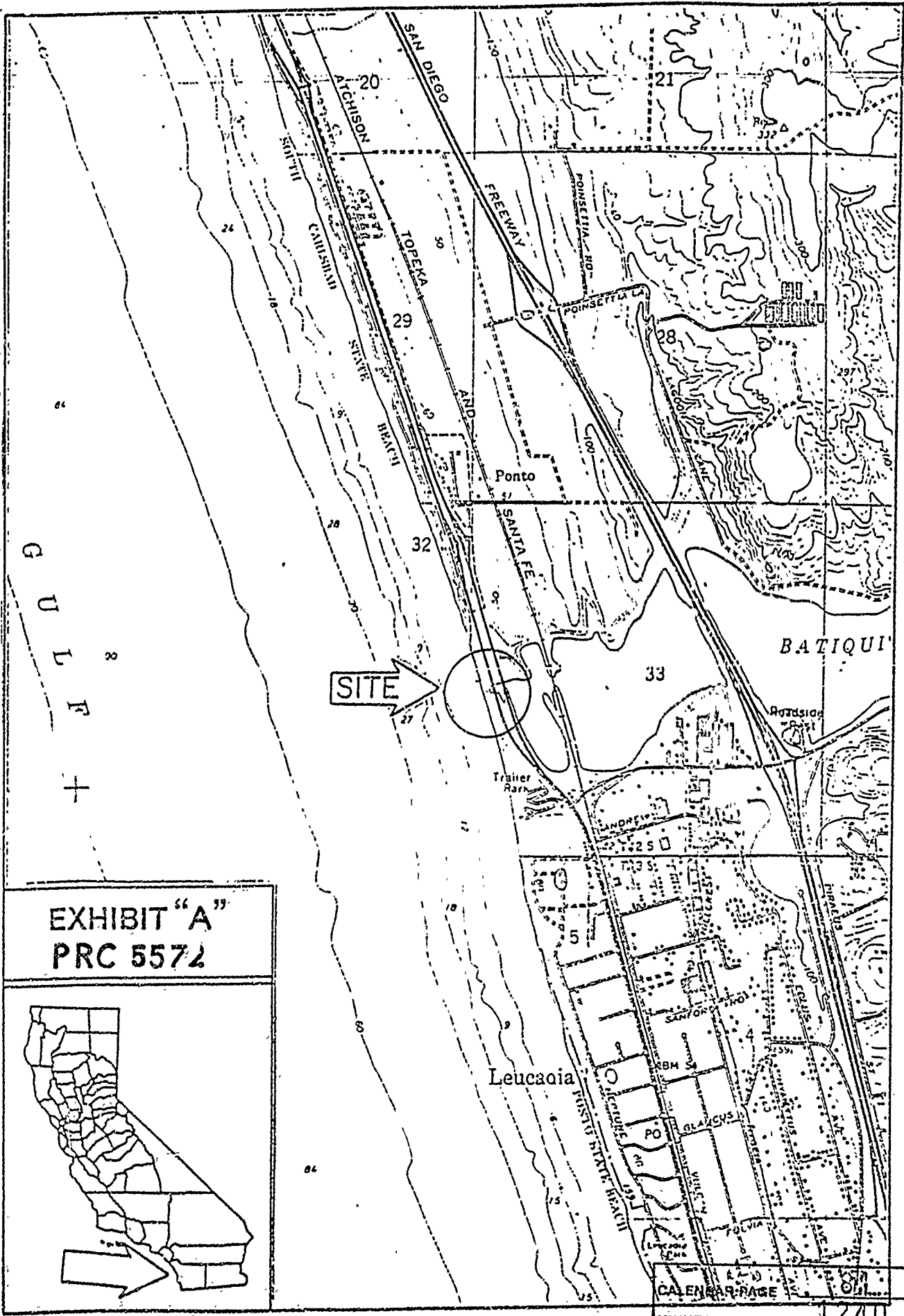

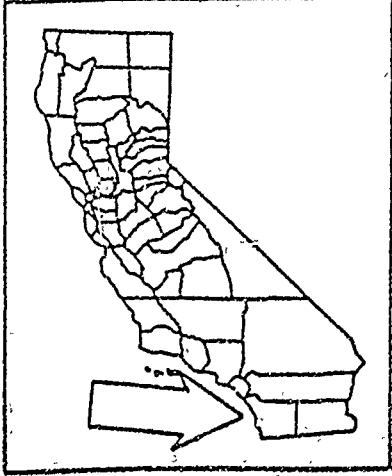

DETERMINE THAT ISSUANCE OF THE PERMIT MODIFICATION TO ALLOW REPLACEMENT OF SUFFICIENT MATERIAL ACROSS THE MOUTH OF BATIQUILOS LAGOON TO PROHIBIT TOTAL EMPTYING OF THE LAGOON WILL HAVE NO SIGNIFICANT ADVERSE EFFECT ON THE ENVIRONMENTAL CHARACTERISTICS, IDENTIFIED PURSUANT TO SECTION 6370.1 ET SEQ., OF THE P.R.C.
