

LAND DESCRIPTION

All that certain parcel of land within the State-owned bed of the Sacramento River, being in the County of Yolo, State of California, more particularly described as follows:

COMMENCING at a point in the centerline of the east levee of Reclamation District No. 811, said point being the northwesterly corner of Parcel A, as shown on that certain Record of Survey map entitled "Portion of Land lying between S.L.S. No. 653 and S.L.S. No. 354 near Broderick", filed in Book 9 of Maps and Surveys, at page 82, in the office of the Yolo County Recorder; thence N 47° 09' E, a distance of 474.0 feet more or less along the northwesterly line of said Parcel A and the northeasterly prolongation thereof to a point on the high water mark on the right bank of the Sacramento River said point being the TRUE POINT OF BEGINNING; thence

N 47° 09' E a distance of 25 feet; thence S 36° 00' E a distance of 82 feet; thence N 54° 05' E a distance of 96 feet; thence S 37° 05' E a distance of 149 feet; thence N 52° 40' E a distance of 68 feet; thence S 38° 10' E a distance of 318 feet; thence S 27° 25' E a distance of 216 feet; thence S 60° 53' 37' W a distance of 169.83 feet, more or less, to the high water mark on the right bank of the Sacramento River; thence meandering upstream along the high water mark on the right bank of the Sacramento River to the point of beginning.

Containing 2.623 acres. Basis of bearings for this description is the centerline of the east levee of said Reclamation District No. 811, being the southwesterly line of the aforementioned Parcel A, said line being shown as N 28° 00' W on said Record of Survey.
