ANNEXATION OF SOVEREIGN PUBLIC TRUST LANDS,
CITY OF LAKEPORT, LAKE COUNTY

The State Lands Commission has received a request from Lake County LAFCO to review and approve the annexation and the boundaries of the proposed Hedden-Turner-Worley Annexation.

This area involves 170[±] acres south of the City of Lakeport. A very small portion (approximately one[±] acre) of the annexation area includes lands falling within the Meander Line of Clear Lake, surveyed May 13, 1867. This small area is entirely within the projected SE¹/₄ of the SE¹/₄, Section 25, T14N, R10W, MDB&N.

Pursuant to Government Code Section 35009, the Commission is to review and approve or deny the proposed annexation and annexation boundaries as appropriate and correct.

The staff of the Commission has reviewed the proposed annexation boundary description and finds it adequate. Furthermore, staff has no objection to transfer of local police power jurisdiction from the County of Lake to the City of Lakeport and, therefore, submits the recommendations of approval below.

APPROVE THE PROPOSED BOUNDARIES OF THE ANNEXATION TO THE CITY OF LAKEPORT AS DESCRIBED IN EXHIBIT "A", ATTACHED AND BY REFERENCE MADE A PART HEREOF, INCLUDING THE PROPOSED ANNEXATION OF SOVEREIGN LANDS HELD IN TRUST, PURSUANT TO CHAPTER 639, STATUTES 1973, AND UNDER THE JURISDICTION OF THE COUNTY OF LAKE WITHIN THE AREA DESCRIBED IN EXHIBIT "A", PURSUANT TO CALIFORNIA GOVERNMENT CODE 35009.
2. AUTHORIZE STAFF COUNSEL TO GIVE THE REQUISITE NOTICES OF SAID APPROVALS TO CITY OF LAKEPORT AND TO THE EXECUTIVE OFFICER OF THE LAKE COUNTY LOCAL AGENCY FORMATION COMMISSION.

Beginning at a point on the Southerly City Limits line as such City Limits were established in the "Marina Annexation No. 2" by Resolution No. 794(71) of the City Council of the City of Lakeport on October 4, 1971, where said Southerly City Limits intersects the easterly line of Section 25, Township 14 North, Range 10 West, M.D.B. & M.; thence South $0^{\circ}47'27''$ West along the westerly line of said Section 25, 330.00 feet to the southeasterly corner of the aforesaid Section 25; thence North $89^{\circ}23'45''$ West along the southerly line of Section 25, 406.5 feet to the northeasterly corner of the lands described in Deed from Dolores Watson et.al. to Frank A. Sylva et.al., recorded August 14, 1980 in Book 1053 of Official Records of Lake County, California at page 121; thence South $19^{\circ}15'00''$ East 515 feet more or less to the southeasterly corner of said lands of Sylva; thence South $70^{\circ}05'00''$ West 599 feet more or less, along the southerly line of the aforesaid lands of Sylva and the westerly prolongation thereof to the westerly line of South Main Street formerly known as the public road leading from Lakeport to Kelseyville; thence North $19^{\circ}15'00''$ West 724.44 feet more or less, along said westerly line of South Main Street to its intersection with the southerly line of Todd Road; thence Westerly along said Southerly line of Todd Road North $89^{\circ}23'45''$ West 1620 feet more or less, to a point on the easterly line of the Northwest 1/4 of Section 36, Township 14 North, Range 10 West, M.D.B. & M. from which point the quarter corner on the North line of

 OF AREA DESCRIBED IN EXHIBIT 'C'.




