GENERAL PERMIT - RIGHT-OF-WAY USE

APPLICANT: General Telephone Company of California  
P. O. Box 176  
Courtland, California 95615

AREA, TYPE LAND AND LOCATION:  
A 0.02-acre parcel of tide and submerged lands,  
in the bed of Sutter Slough, Mile 6.48, in  
Sacramento and Yuba Counties.

LAND USE: Armored submarine communication cable.

TERMS OF PROPOSED PERMIT:  
Special: Continuous use plus one year  
from September 1, 1982.

CONSIDERATION: Exempt by law, Public Utilities Code 7901.

BASIS FOR CONSIDERATION:  
Pursuant to Cal. Adm. Code 2003 and Public  
Utilities Code 7901.

PREREQUISITE TERMS, FEES AND EXPENSES:  
Applicant is permittee of upland.

Filing fee and processing costs have been

United States Army Corps of Engineers and the Department of Fish and Game.

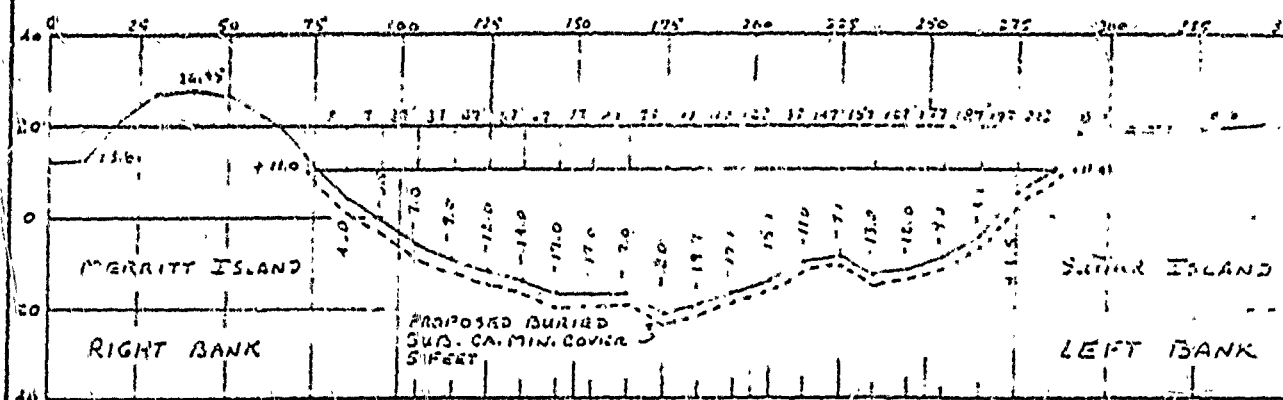
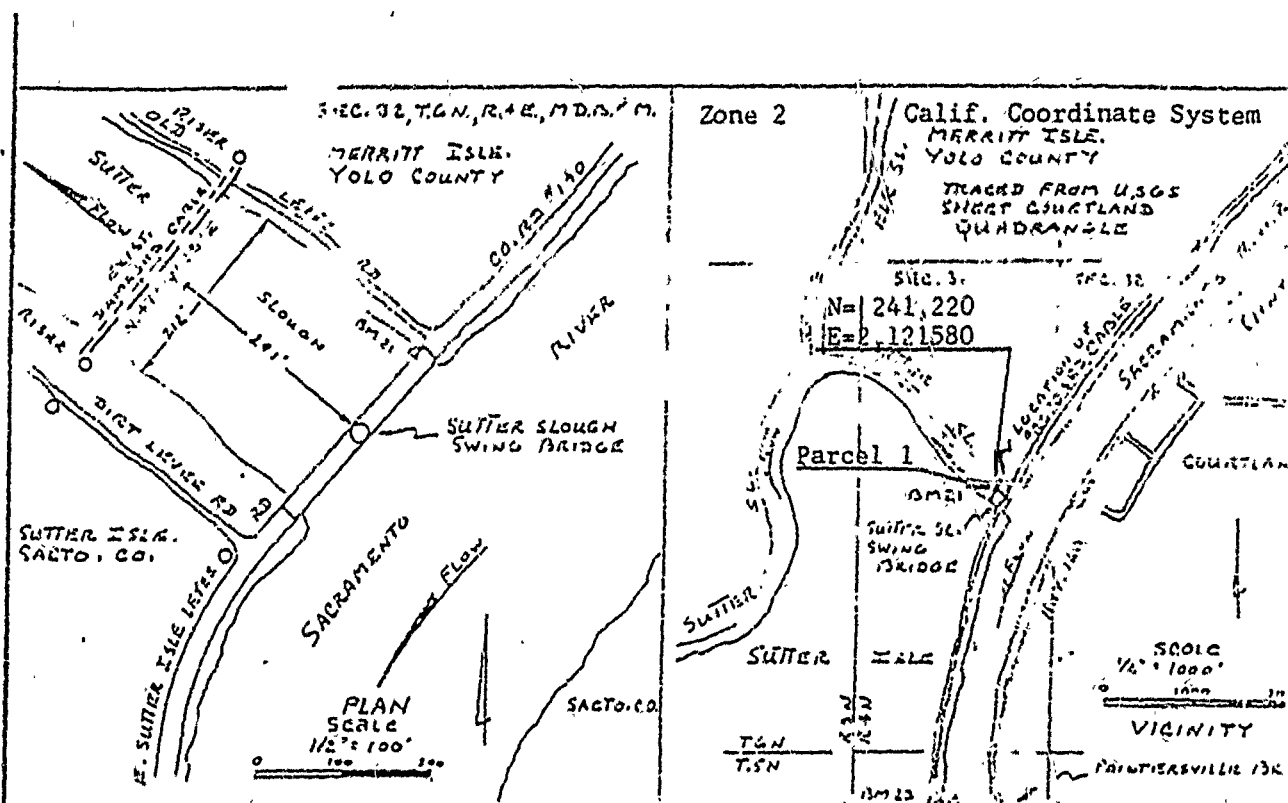

- 1. DETERMINE THAT AN ENVIRONMENTAL DOCUMENT HAS NOT BEEN PREPARED FOR THIS ACTIVITY AS SUCH DOCUMENT IS NOT REQUIRED UNDER THE PROVISIONS OF P.R.C. 21084, 14 CAL. ADM. CODE 15100 ET SEQ., AND 2 CAL. ADM. CODE 2905; AND FIND THAT THE PROJECT IS CONSISTENT WITH ITS USE CLASSIFICATION.

2. AUTHORIZE ISSUANCE TO GENERAL TELEPHONE COMPANY OF CALIFORNIA OF A CONTINUOUS USE PLUS ONE YEAR GENERAL PERMIT - RIGHT-OF-WAY USE, FROM SEPTEMBER 1, 1982, WHICH IS EXEMPT FROM CONSIDERATION, PURSUANT TO PUBLIC UTILITIES CODE 7901; FOR CONSTRUCTION, OPERATION AND MAINTENANCE OF AN ARMORED SUBMARINE COMMUNICATION CABLE ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

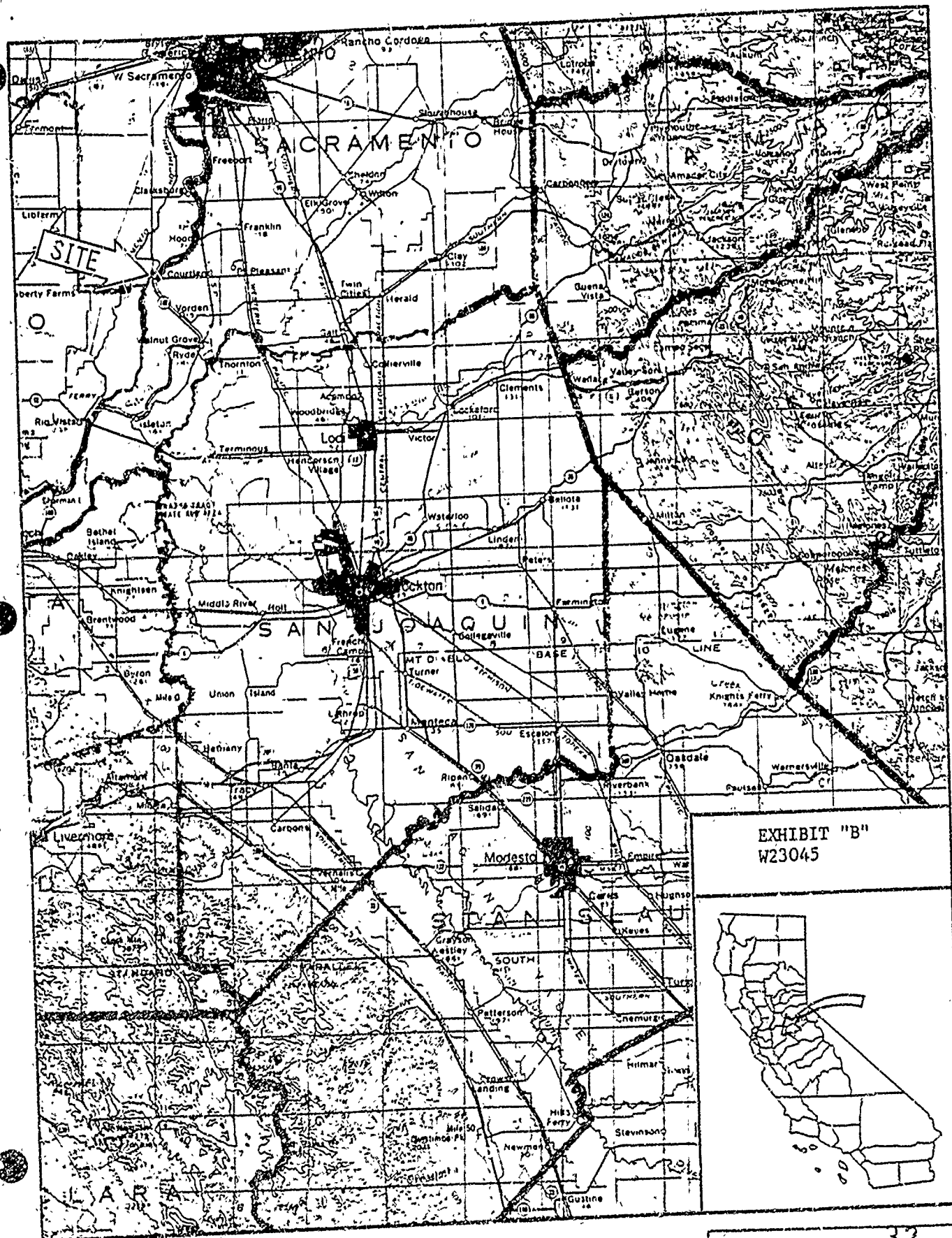
