GENERAL PERMIT - PUBLIC AGENCY USE

APPLICANT: Department of Public Works  
County of Humboldt  
1106 Second Street  
Eureka, California 95502

AREA, TYPE LAND AND LOCATION:  
A 0.576-acre parcel of tide and submerged  
land located in the Mad River, Humboldt  
County.

LAND USE: Right-of-way for a recreational bike, equestrian  
and hiking trail.

TERMS OF PROPOSED PERMIT:  
Initial period: 48 years from August 5,  
1982.

CONSIDERATION: The public use and benefit, with the State  
reserving the right at any time to set  
a monetary rental if the Commission finds  
such action to be in the State's best interest.

BASIS FOR CONSIDERATION:  
Pursuant to 2 Cal. Adm. Code 2003.

PREREQUISITE TERMS, FEES AND EXPENSES:  
Applicant is permittee of upland.

OTHER PERTINENT INFORMATION:

1. The Department of Public Works, Humboldt County, plans to construct a five-mile recreational trail from the Mad River to Clam Beach County Park, of which a segment involves a railroad bridge over the Mad River that will be the lease area of the proposed permit. The approaches to the bridge will require construction of ramps and two separate eight-foot wide paths; one for bicycles, and one for horses and pedestrians. The Department of Public Works has entered into a management agreement for maintenance of the structure with McKinleyville Community Services District, which owns the bridge and is the permittee under Lease PRC 5184.1, General Permit - Public Agency Use, with a beginning date of August 5, 1981.
2. Staff recommends that the processing expense fee of \$450 be waived inasmuch as the lease area is presently leased to McKinleyville Community Services District for another use.
3. The annual rental value of the site is estimated to be \$1,500.
4. A Negative Declaration was prepared and certified by the County of Humboldt, pursuant to CEQA and the State EIR Guidelines. The County of Humboldt found that the project will not have a significant effect on the environment.

5. The project is situated on lands identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in use category "B" which authorizes Limited Use. The project as proposed will not have a significant effect upon the identified environmental values.

IT IS RECOMMENDED THAT THE COMMISSION:

1. DETERMINE THAT A NEGATIVE DECLARATION HAS BEEN PREPARED FOR THIS PROJECT BY THE COUNTY OF HUMBOLDT.
2. CERTIFY THAT THE COMMISSION HAS REVIEWED AND CONSIDERED THE INFORMATION CONTAINED IN THE NEGATIVE DECLARATION.
3. DETERMINE THAT THE PROJECT WILL NOT HAVE A SIGNIFICANT EFFECT ON THE ENVIRONMENT; AND FIND THAT THE ACTIVITY IS CONSISTENT WITH ITS USE CLASSIFICATION.
4. APPROVE WAIVER OF PROCESSING EXPENSE FEE.
5. AUTHORIZE ISSUANCE TO THE DEPARTMENT OF PUBLIC WORKS, COUNTY OF HUMBOLDT OF A 48-YEAR GENERAL PERMIT - PUBLIC AGENCY USE, FROM AUGUST 5, 1982; IN CONSIDERATION OF THE PUBLIC USE AND BENEFIT, WITH THE STATE RESERVING THE RIGHT AT ANY TIME TO SET A MONETARY RENTAL IF THE COMMISSION FINDS SUCH ACTION TO BE IN THE STATE'S BEST INTEREST; FOR RIGHT-OF-WAY USE FOR A RECREATIONAL BIKE, EQUESTRIAN AND HIKING TRAIL ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

LAND DESCRIPTION

W 23048

A parcel of land lying in the State-owned bed of the Mad River, Humboldt County, State of California, being within the NE-1/4 of the NE-1/4 of Section 12, T6N, R1W, HM, said parcel being 66 feet wide and lying 33 feet on each side of the centerline of the main track of the California and Northern Railway Company, said parcel being as shown on the plat approved by the Surveyor General on the 21st day of July, 1900, and designated by the State Lands Commission as LRT 30.

EXCEPTING THEREFROM any portion lying landward of the ordinary high water mark of the Mad River.

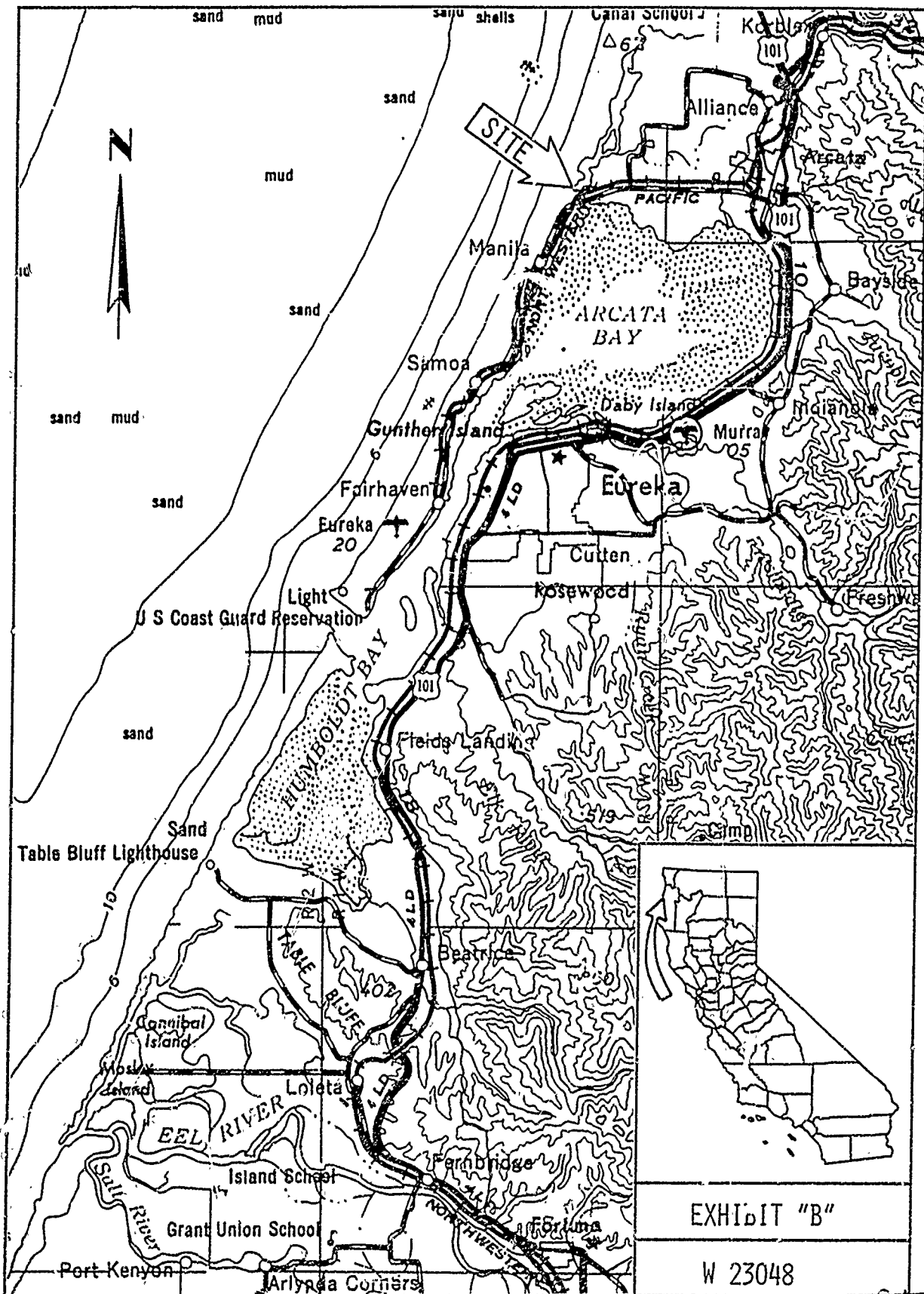

Project Description: Construct a five mile recreational trail from Mad River to Clam Beach County Park along an old railroad bed. Two separate paths would be constructed: one for bicycles, and one for horses and pedestrians. Both paths will be eight feet wide.


