# SALVAGE PERMIT

APPLICANT: The Brother Jonathan Company P. O. Box 1190 Crescent City, California 95531

AREA, TYPE LAND AND LOCATION: Three parcels of tide and submerged lands totaling 27 acres in the Pacific Ocean near Crescent City, Del Norte County.

LAND USE: Selective salvage of artifacts from the British freighter Queen Christina that sank in 1907 and salvage of artifacts and the remaining intact hull of the Brother Jonathan, a passenger ship, that sank in 1865.

TERMS OF PROPOSED PERMIT: Initial period: One-year from November 1, 1982.

> Public liability insurance: Combined single limit coverage of \$300,000.

CONSIDERATION: \$675 - use of land area for one year. 25 percent of the net salvage value of \$25,000 or less, and 50 percent of the net salvage

OTHER PERTINENT INFORMATION:

- A salvage permit was authorized to the Brother Jonathan Company at the November 20, 1979 Commission meeting, Calendar Item 17, for the salvage of the Queen Christina, but was rescinded at the August 24, 1980 Commission meeting, Calendar Item 8, per request of the applicant due to time delays and financial constraints.
- 2. The applicant has now reapplied for a salvage permit to remove selective artifacts from the Queen Christina, A British freighter that sank in 1907, and to salvage the artifacts and the remaining intact hull of the Brother Jonathan, a passenger ship that sank in 1865.

Removal of artifacts from both vessels will be performed largely by hand with the aid of small air lift devices. To salvage the hull of the Brother Jonathan an air flotation device will be employed.

- 3. All items removed from the site will be catalogued and warehoused in quarters meeting the approval of the Commission staff until their diposition is decided. The applicant proposes to place all salvaged items not retained by the State in a private museum to perpetuate the maritime history of the Northern California Coast.
- 4. Staff has coordinated this project with the Office of Historic Preservation and will keep them apprised of the recovery of all material removed from the site.
- 5. Negative Declarations were prepared and certified by the State Lands Commission, pursuant to CEQA and the State CEQA Guidelines. The staff of the Commission found that the projects will not have a significant effect upon the environment.
- 6. The projects are rituated on lands identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and are classified in a use category "B" which authorizes Limited Use. The projects as proposed will not have a significant effect upon the identified environmental values.
- 7. This project is exempt from United States Army Corps of Engineers permit in purview of Section 10 of the River and Harbor Act which became regulation July 22, 1982.



# NEGATIVE DECLARATION

#### Salvage of the Queen Christina

# W 21068

This Negative Declaration is prepared pursuant to Section 15083, California Administrative Code, Title 14, Division 6 and is based upon an Initial Study pursuant to Sections 15080 and 15066 thereof.

#### Description

It is proposed to selectively salvage antifacts from a freighter that sank in 1907. The operation will take place near Crescent City, specifically off Point St. George in shallow water. It is expected that only a few days will be required for the project, although this is dependent on the weather. All items found will be catalogued and be the property of the State until their disposition is determined. The salvor intends to place all materials found and kept into a private museum for the maritime history of the northern California coast.

# Determination

An Initial Study has been prepared and it is determined that the proposed project will not have a significant effect upon the environment.

(1) The proposed project will have no cumulative impacts, or adverse effects on humans.

(2) There will be minimal impacts upon fish and other marine organisms of the project environment.

(3) Salvage of the <u>Queen Christina</u>, a British freighter of a historical period is believed to be noncontroversial in terms of the historical elements of CEQA and the California History Plan. This determination rests upon the type of vessel, no cargo, and possible prior salvage. See attachment to Initial Study checklist.

(4) Uses of public services, energy, and other resources are not applicable or are insignificant.
