DREDGING PERMIT

APPLICANT: Atkinson Marine  
P. O. Box 13669  
San Diego, California 92113

AGENT: Ferber Engineering  
1313 West 24th Street  
National City, California 92050.

AREA, TYPE LAND AND LOCATION: Granted lands at the city of National City to the San Diego Unified Port District with minerals reserved. Submerged lands in San Diego Bay at the National City Marine Terminal, San Diego County, California.

LAND USE: Dredge 680,000 cubic yards of sediments to prepare a basin for floating drydock barge and pier. Spoils to be deposited at an authorized United States Army Corps of Engineers dumpsite, located in the Pacific Ocean, ten nautical miles southwest of the project site.

TERM OF PERMIT: Initial period: One year from August 1, 1982.

CONSIDERATION: A royalty of \$0.15 per cubic yard is to be charged for State-owned spoils deposited in the United States Army Corps of Engineers

Disposal Site, L.A. 5, located in the Pacific Ocean, ten nautical miles southwest of the project site, or placed on private uplands, or sold for commercial benefit.

The planned disposal site is the United States Army Corps of Engineers Disposal Site, L.A. 5, located in the Pacific Ocean, ten miles southwest of the project site.

PREREQUISITE TERMS, FEES AND EXPENSFS:

Filing and extractive development fees have been received.

3. This project is situated on State lands identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in use category class "C" Multiple Use.

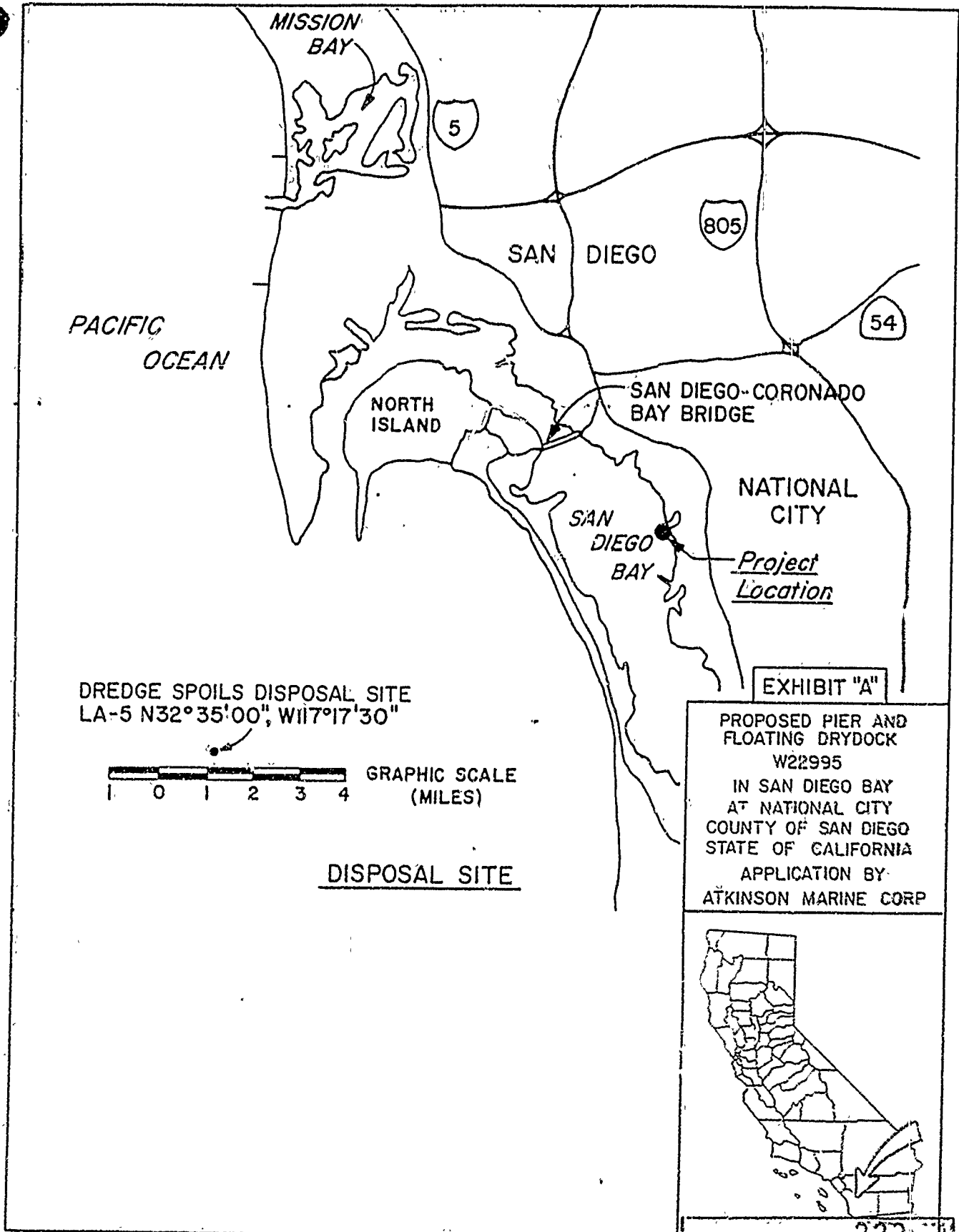
1. CERTIFY THAT AN ENVIRONMENTAL DOCUMENT HAS BEEN PREPARED FOR THE PROJECT BY THE SAN DIEGO UNIFIED PORT DISTRICT IN COMPLIANCE WITH THE REQUIREMENTS OF CEQA AND THAT THE COMMISSION HAS REVIEWED AND CONSIDERED THE INFORMATION CONTAINED THEREIN PRIOR TO THE APPROVAL OF THE PROJECT.
2. DETERMINE THAT THE PROJECT WILL NOT HAVE A SIGNIFICANT EFFECT ON THE ENVIRONMENT.
3. FIND THAT GRANTING OF THE PERMIT WILL HAVE NO SIGNIFICANT

EFFECT UPON ENVIRONMENTAL CHARACTERISTICS IDENTIFIED  
PURSUANT TO SECTION 6370.1 OF THE P.R.C.

4. AUTHORIZE THE STAFF OF THE STATE LANDS COMMISSION TO ISSUE TO ATKINSON MARINE THE DREDGING PERMIT ON FILE IN THE OFFICES OF THE COMMISSION; SAID PERMIT SHALL BE ISSUED IN CONSIDERATION OF A ROYALTY OF \$0.15 PER CUBIC YARD FOR DREDGED MATERIALS PLACED IN THE UNITED STATES ARMY CORPS OF ENGINEERS APPROVED DISPOSAL SITE L.A. 5, AND A ROYALTY OF \$0.25 PER CUBIC YARD FOR SPOILS PLACED ON PRIVATE LANDS, OR SOLD FOR COMMERCIAL BENEFIT; SAID PERMIT SHALL BE FOR A PERIOD OF ONE-YEAR BEGINNING AUGUST 1, 1982, AND SHALL ALLOW THE DREDGING OF A MAXIMUM OF 680,000 CUBIC YARDS OF MINERALS OTHER THAN OIL, GAS AND GEOTHERMAL FROM AN AREA OF GRANTED TIDE AND SUBMERGED LANDS IN SAN DIEGO BAY AT THE NATIONAL CITY MARINE TERMINAL, NATIONAL CITY, SAN DIEGO COUNTY, CALIFORNIA; SAID AREA IS SHOWN ON EXHIBIT "B" ATTACHED HERETO AND BY THIS REFERENCE EXPRESSLY MADE A PART HEREOF; THE MATERIAL DREDGED SHALL BE DEPOSITED IN A DISPOSAL SITE APPROVED BY ALL APPLICABLE REGULATORY AGENCIES: THE COMPLETE PERMIT IS CONTAINED IN FILE W 22995, LOCATED IN THE COMMISSION OFFICES.

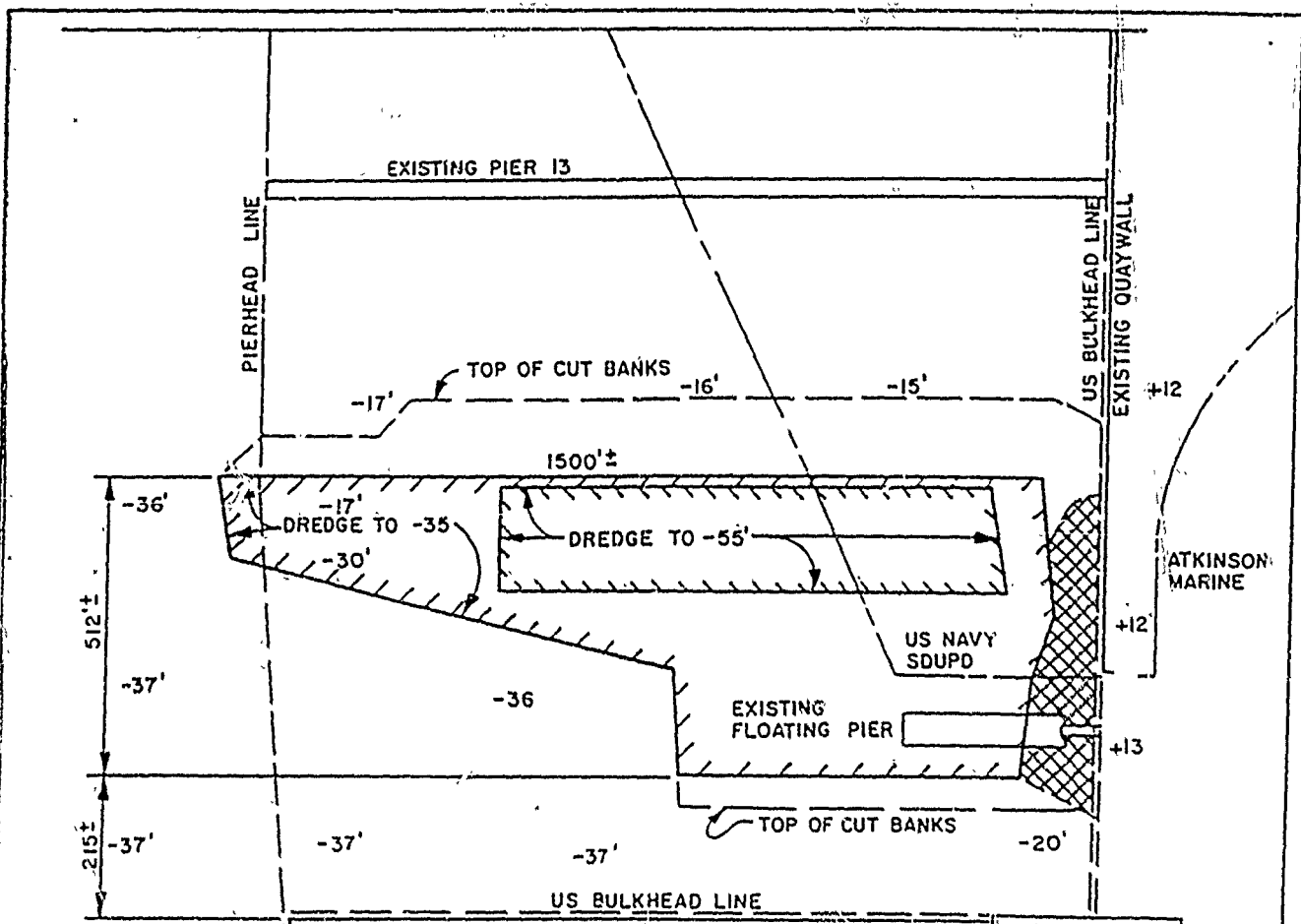
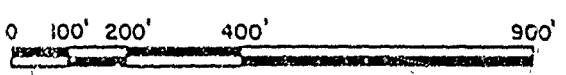
