### AUTHORIZATION TO FILE A LIMITED DISCLAIMER

The State Lands Commission is a party to a condemnation action brought by San Diego County involving three parcels of land in and adjacent to San Elijo Lagoon. The case is entitled County of San Diego v. Raymond V. Johnson, et al, Superior Court No. 47021 (Parcel 75-0203-AL).

The State was named as to one of the parcels only. As to that parcel, an examination of the Commission's records pertinent to the subject area shows that a significant portion of the property to be present and historic tide and submerged land. As to these lands, the County of San Diego has agreed that it does not seek to condemn any sovereign interest of the State involving public trust lands.

The State Lands Commission has previously issued public agency permits to the Department of Fish and Game who together with San Diego County are operating San Elijo Lagoon as a regional park and ecological reserve.

It is contemplated by staff that as to the public trust lands involved in this condemnation action, the Department of Fish and Game, and/or the County of San Diego will seek an amendment of the existing permit to include these lands as part of the reserve.

Therefore, in order to protect the lands which are public trust lands within the condemnation parcel, an authorization to enter a limited disclaimer - involving nontrust lands -- and a stipulation as to the country's not seeking condemnation of trust property is approp\_ ate.
