AUTHORIZATION TO FILE A DISCLAIMER OF SELECTED PARCELS IN CITY OF EUREKA V. STATE OF CALIFORNIA, ET AL., SUPERIOR COURT OF CALIFORNIA, COUNTY OF HUMBOLDT, CASE NOS. 71031 AND 69966

The State Lands Commission is a party to a condemnation action brought by the City of Eureka to acquire land for its wastewater treatment plant. The lawsuit deals with numerous parcels of land and is entitled <u>City of Eureka v.</u> <u>State of California, et al.</u>, Superior Court of California, <u>County of Humboldt</u>, Case Nos. 71031 and 69966. Sovereign tide and submerged lands within these parcels have been granted to the City of Eureka by Ch. 225, Stats. of 1945 and to the Humboldt Bay Harbor, Recreation and Conservation District by Ch. 1283, Stats. of 1970.

An examination of the Commission's records has shown that there is no sovereign interest held by the City, the Harbor District, or the State in some of the tracts involved in this lawsuit. These tracts are denominated parcels A, B, E, G, H, L, and M. It is recommended that the State Lands Commission file a disclaimer of interest in these particular tracts since it has no interest in them. It is also recommended that the State Lands Commission authorize the City of Eureka to condemn these parcels without seeking an adjustment in value to compensate for any granted lands interest since the City has no such interest.


