OTHER PERTINENT INFORMATION:

1. On August 20, 1961, the Commission approved a lease to Robert Griffin, dba Suisun Pacific Marina, after negotiated settlement in lieu of litigation, to operate a commercial marina on the subject land with a beginning date of March 1, 1981. On September 15, 1981, the upland and marina was purchased by the applicant, Wayne A. Anderson, who renamed the marina Whispering Bay Narina. The annual rental was paid through February 28, 1982. The intent of issuing the proposed lease is to replace the terminating lease in kind, not to expand or revise the terms.

Staff recommends that the Commission approve waiver of payment for occupation of State land, for the period march 1, 1982, through August 31, 1982, inclusive, and charge the applicant \$333.33, a proration of the annual minimum rent, for occupation of the proposed lease area September 1, 1982, through December 31, 1982. Due to silting in the lease area and Suisun Slough Channel, the marina was inoperable as an economic enterprise until anticipated dredging was done. Suisun City contracted with the United States Army Corps of Engineers to dredge the channel. However, because of deferred maintenance of the marina use area, at low tide it is unuseable. The applicant proposes to dredge the tide and submerged land within the lease area in the near future.

- 2. This project is exempt from CEQA because it is an existing facility in an acceptable state of repair, and involves maintenance dredging. Authority: Title 2, Div. 3, Cal. Adm. Section 2905, Class 1, and Title 14, Div. 6, Cal. Adm. Code, Section 15104(g).
- 3. The project is situated on lands identified as possessing significant environmental values pursuant to P.R.U. 6370.1 and is classified it a use category "B" which authorizes Limited Use. The project as proposed will not have a significant effect upon the identified environmental values.
