- This project is exempt from CEQA because

 state of repair.
- 2. The project is situated on lands identified as possessing significant environmental values pursuant to P.R.C. 6370.1 and is classified in a use category "B" which authorizes Limited Use. The project as proposed will not have a significant effect upon the identified environmental values.
- 3. Section 2 of the permit conforms to the Lyon/Fogerty decision.
- 4. The upland owner, I. G. Zumwalt Company, has given its written consent to the permittee to maintain the float adjacent to their property.
- 5. In light of the time lapse since the original application was filed, and the lack of regular correspondence with the applicant, staff feels it would be in the best interest of the State and recommends that back rent, penalty and interest, if any, be waived for the period of September 26, 1972, through October 23, 1979.
