LETTER OF PERMISSION - WILDLIFE CONSERVATION BOARD PRC 5879.9

A LETTER OF PERMISSION WAS GRANTED TO THE WILDLIFE CONSERVATION BOARD IN ADVANCE OF AMENDING EXISTING PRC 5879.9 FOR CONSTRUCTION OF A 5,000 SQUARE FOOT PARKING AREA AND A 500 LINEAR FOOT PUBLIC ACCESS ROAD WITHIN THE PRESENT LEASE USED FOR THE LAKE EARL WILDLIFE AREA.

IT IS NECESSARY FOR THE PROPOSED WORK TO BE PERFORMED NOW TO INSURE COMPLETION UNDER THE AUTHORIZED 1982-1983 BUDGET; THE WILDLIFE CONSERVATION BOARD WILL OBTAIN THE REQUIRED MODIFICATION OF THE EXISTING LEASE.

THIS ACTIVITY IS CATEGORICALLY EXEMPT UNDER CEQA AND THE STATE CEQA GUIDELINES BECAUSE IT INVOLVES CONSTRUCTION OF A SMALL NEW FACILITY. AUTHORITY: 14 CAC, DIV. 6, SEC. 15103.

SAN FRANCISCO BAY CONSERVATION AND DEVELOPMENT COMMISSION

PIER 39

After lengthy debate, on May 19 the San Francisco Bay Conservation and Development Commission unanimously approved an amendment to an application of Fier 39 Limited Partnership and the Port of San Francisco to reconfigure their east side marina and construct a new breakwater to replace the existing floating tire breakwater. To raise the revenue needed to build the new breakwater, Fier 39 proposed to sell long-term subleases (59 years each) of individual marina slips for private recreational uses. This "dockominium" concept raised significant public trust issues during the three hearings.

At the April 19 and May 5 public hearings, the staff of this Commission strongly opposed this proposal because of the long-term exclusive use. The staff contended that the Pier 39 marina project is a very valuable piece of public tide and submerged lands, with important public recreational uses, and would no longer be available to the public. Instead, for the next 59 years, it would be devoted exclusively to the benefit and enjoyment of the 351 "winners" at the Pier 39 auction and their heirs.

After several meetings with the applicant, we were able to reach a compromise that addressed some of our main concerns. This compromise was based on the fact that Pier 39 was unique because an important marina would cease operation if an adequate breakwater was not constructed, and to build the needed breakwater would require millions of dollars which were not immediately available through conventional sources.

BCDC finally approved the amendment to the application subject to Pier 39 maintaining a minimum of 68 slips available for rental on a month-to-month basis with rentals and resales taken from a waiting list maintained by the Pier 39 management on a first come, first served basis.
