RECISSION OF PRIOR AUTHORIZATION FOR ISSUANCE OF A GENERAL LEASE - COMMERCIAL USE

APPLICANT: American Enertech P. O. Box 985 Bellevue, Washington 93009

AREA, TYPE LAND AND LOCATION: A 0.045-acre parcel of submerged land located in the Sacramento River near Meridian, Sutter County.

LAND USE: Installation and maintenance of a floating platform to support a hydroelectric generation unit.

TERMS OF LEASE:

Initial period: 25 years from May 1, 1982.

Surety bond: \$2,000.

Public liability insurance: Combined single limit coverage of \$200,000.

CONSIDERATION: \$250 per annum, with the State reserving the right to fix a different rental on each fifth anniversary of the lease.

First year's rent has been retained to cover the processing expense.

  - The Commission authorized the issuance of the subject lease on June 29, 1982, Minute Item 13.
  - Due to internal problems of the company and infeasibility of the project, the company and the project are being cerminated.
  - This activity is exempt from CEQA because it is not a project pursuant to P.R.C. 21065, 14 Cal. Adm. Code 15037 and 15060.
  - 5. The activity is situated on lands identified as possessing significant environmental values pursuant to P.R.C. 6370.1 and is classified in a use category "B" which authorizes Limited Use. The activity as proposed will not have a significant effect upon the identified environmental values.


