AUTHORIZATION OF TERMINATION OF LEASE PRC 3519.1

APPLICANT: Chevron USA, Inc.
2120 Diamond Boulevard
Concord, California 94520

BACKGROUND: On April 28, 1983, the State Lands Commission ratified the lease terms for General Lease PRC 6417.1, approved by the Commission on December 16, 1982, covering two parcels of land for construction and maintenance of a submarine gas pipeline and power cable and maintenance of an existing outfall pipeline.

CURRENT SITUATION:

The outfall line is no longer to be used as a discharge line as provided for in Lease PRC 3519.1, and instead is to be used to facilitate an electric cable as provided for in Lease PRC 6417.1. Therefore, Lease PRC 3519.1 should be terminated.

This activity is exempt from CEQA because it is not a project within the meaning of CEQA and the State CEQA Guidelines.
