DREDGING PERMIT

In accordance with the Commission's delegation of authority to the Executive Officer for the issuance of dredging permits of 10,000 cubic yards or less (Minute Item 32, February 24, 1977) permission was granted to perform maintenance dredging on State-owned lands to the following party:

Paradise Development Corporation  
10971 Lakeshore Drive  
Clearlake Park, California 95424

The permit provides for dredging approximately 1,000 cubic yards of sediments from submerged lands in the bed of Clear Lake, Lake County.

Dredging is required to remove a plug in the mouth of a lagoon. Material will be dredged from the mouth and placed on adjacent private uplands belonging to the applicant. A royalty of \$0.25 per cubic yard will be charged for all material removed (see map Exhibit "A"). The permit is effective November 1, 1982 through October 31, 1983. An Initial Study and mitigated Negative Declaration were prepared and circulated by Lake County with no further comments.

IN COMPLIANCE WITH SAID DELEGATION OF AUTHORITY IT HAS BEEN DETERMINED THAT THE FOLLOWING CONDITIONS HAVE BEEN MET:

1. THE PROPOSED PROJECT IS CATEGORICALLY EXEMPT FROM THE REQUIREMENTS OF CEQA, PURSUANT TO THE PROVISIONS OF SECTION 15104(G) OF THE CEQA GUIDELINES, PERTAINING TO MAINTENANCE DREDGING.
2. ISSUANCE OF THE PERMIT AND THE RESULTANT PROJECT WOULD HAVE NO ADVERSE EFFECT ON THE ENVIRONMENT OR THE ENVIRONMENTAL CHARACTERISTICS IDENTIFIED PURSUANT TO SECTION 6870.1 ET SEQ., OF THE P.R.C.
3. THE DREDGING AMOUNT WILL NOT EXCEED 10,000 CUBIC YARDS.
4. A ROYALTY OF \$0.25 PER CUBIC YARD WILL BE ASSESSED FOR SPOIL MATERIAL THAT IS DEPOSITED ON PRIVATE PROPERTY.
5. APPROVAL OF THE PROJECT WILL BE CONTINGENT UPON APPROVAL BY ALL PERTINENT STATE, FEDERAL AND LOCAL AGENCIES.

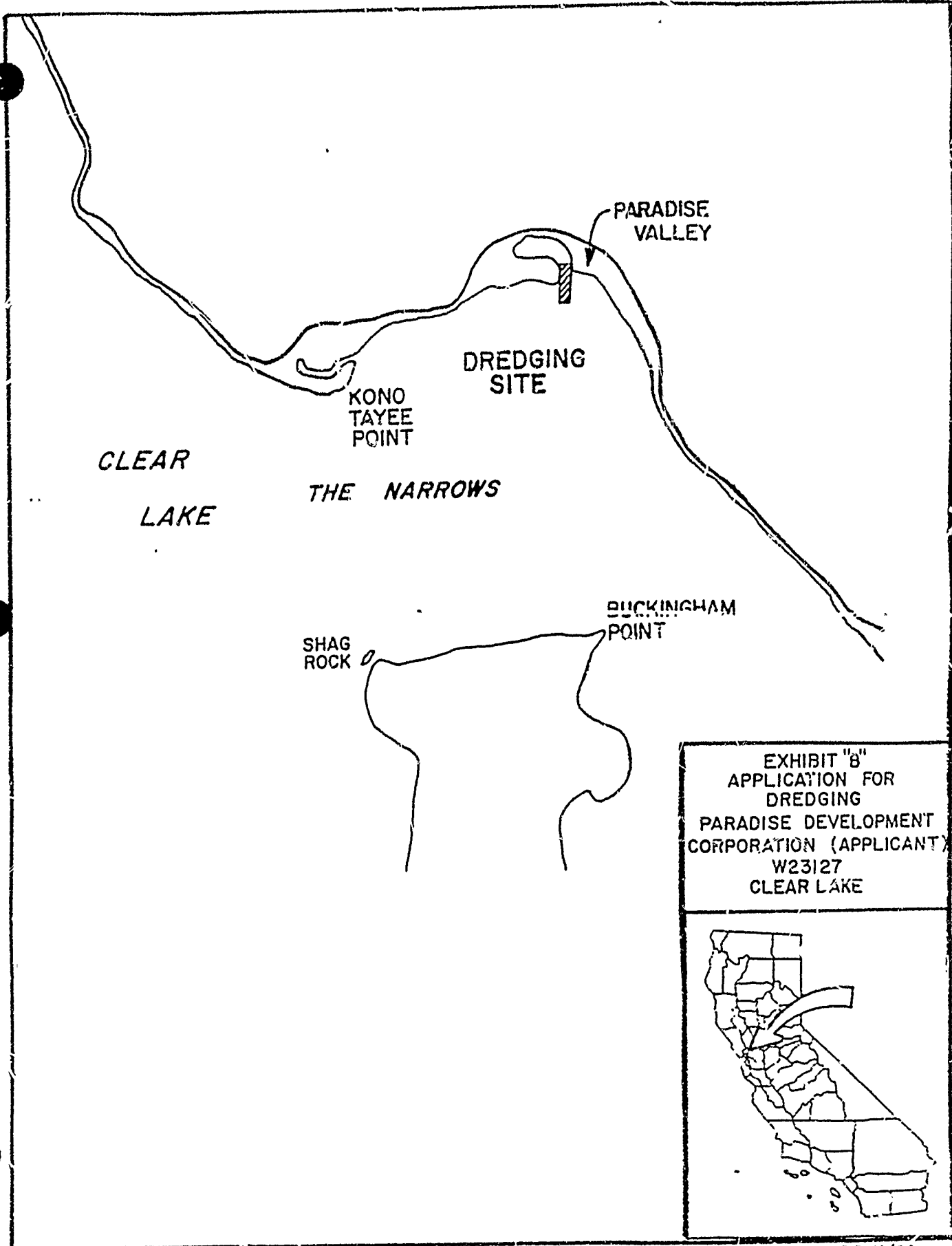
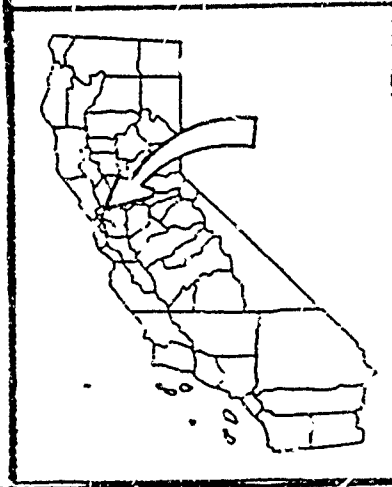
