ACCEPTANCE OF LAND DONATION FROM PPG INDUSTRIES, INC., AT OWENS DRY LAKE IN THE VICINITY OF BARTLETT, INYO COUNTY

BACKGROUND:

In 1958, PPG Industries, Inc., ceased operation of its soda ash plant at Bartlett, California. PPG's operations included lake land leased from the State Lands Commission, a Lakeland Location parcel, and four upland parcels lying landward of the United States Meander Line along the shoreline of Owens Lake.

In 1981, when the State Lands Commission proposed to construct a demonstration solar pond power plant at Owens Lake, PPG offered to donate its land to the State and to Inyo County. This donation of land is the implementation of that offer.

DESCRIPTION OF LAND TRANSFER:

The parcels shown approximately in Exhibit "A" and described in Exhibit "B" will be donated to the State and County as follows:

- o PPG will deed to the County all right, title and interest in the parcel labeled "Deeded to County".
- o PPG will deed to the State all right, title and interest to the parcels labeled "Deeded to State".

o PPG and the County will quitclaim to the State any interest they may have or acquire as a part of this transaction, waterward of the United States Meander Line.

OTHER PERTINENT INFORMATION:

- 1. Owens Lake, though presently dry, is impressed with the public trust for commerce, navigation and fishing. The donated parcels located landward of the United States Meander Line are free of the trust.
- 2. The lake lands adjacent to the parcels to be acquired have not been identified as possessing significant environmental values pursuant to PRC 6370.1.
- 3. This proposed action involves the donation of land and not a specific use for the acquired land. Therefore, this action does not constitute a "project" pursuant to the California Environmental Quality Act (PRC 21065).
- 4. Staff has reviewed preliminary citle reports for the subject parcels and has inspected the property to ensure that no undue hazards exist on it. In addition, an on-site investigation by the State Department of Health concluded that the property is free of any hazardous wastes which may have been associated with the prior PPG use of the subject land.
- 5. Staff has also worked with representatives of PPG and the County to draw up the terms and conditions of this land transfer as reflected in the Letter of Understanding (Exhibit "B") and its amending letter from Mr. W. R. Harris (Exhibit "D").



LETTER OF UNDERSTANDING BETWEEN PPG Industries, Inc., ("PPG")

and

the State of California,
Acting by and through the State Lands Commission

and

the County of Inyo, (collectively sometimes "donees")

Dated as of May 16, 1983

SUBJECT: Donation of 432 Acres, More or Less, of Land, Including All Buildings and Improvements Located Thereon, in Inyo County, California

This letter of Understanding confirms the understandings between PPG and the donees concerning a donation by PPG to the donees of some 432 acres of land, more or less, owned by PPG and located in Inyo County, California, including all buildings and improvements on the said land (hereinafter "donated properties.") The donation shall be completed pursuant to the outline discussed in this Letter of Understanding.

1. Description of Donated Properties.

The donated properties shall consist of the lands described in Exhibits "A" and "B" attached hereto and made a part hereof, including all buildings and other improvements located thereon. The State of California, acting by and through the State Lands Commission, shall receive those lands described in Exhibit A. The County of Inyo shall receive those lands described in Exhibit B.

2. Condition of the Land.

- A. The donation is being made on an "as is, where is" basis, that is,

 PPG makes no representations or warranties, either expressed or implied,

 as to the land, the buildings, or the improvements thereon, or the respective

 condition, suitability for use, or fitness for any particular purpose of

 the donated properties or any part thereof.
- B. PPG hereby discloses, and the donees acknowledge that the donated properties had been used by PPG as a chemical manufacturing facility. PPG further discloses that the manufacturing plant has been dismantled and removed and that, without making any warranties, PPG has no knowledge that the donated properties contain appreciable amounts of hazardous or toxic substances resulting from PPG's operations on the donated properties.

3. Method of Conveyance.

- A. Title to the donated properties shall be transferred to the donces by Grant Deeds.
- B. PPG shall quitclaim to the State of California, acting by and through the State Lands Commission, all right, title, and interest of PPG in and to any lands below the Federal meander line of Owens Lake, as described in Exhibit C hereto.
- C. The County of Inyo shall quitclaim to the State of California, scting by and through the State Lands Commission, all right, title, interest of the County in and to any lands lying below the Federal meander line of Owens Lake, as described in Exhibit D hereco.

4. Quality of Title.

- A. All current taxes and assessments shall be prorated as of the date the escrow for this donation is disbursed.
- B. Title shall be granted subject to any and all conveyances, covenants, restrictions, reservations, exceptions, ordinances, oil, gas, or other mineral leases, or encumbrances of record.
- C. Title shall be granted subject to any and all easements, rights-of-way, roads or railroads, recorded or unrecorded, which affect the donated properties.
- D. Except for the parcel of land known commonly as the "lake-lands" property, which is Parcel No. 1 in Exhibit A hereto, PPG shall retain all coal, oil, gas, and other minerals of whatsoever nature or kind lying 2,000 feet or more beneath the surface of the donated properties, including therewith the right to explore, dig, mine, extract, use, and/or remove any and all such coal, oil, gas, or other minerals which may be found, but not including any right of PPG to enter upon the surface of the donated properties to conduct such activities.

5. Title Insurance.

A. Before disbursement of the escrow, PPG shall secure title commitments from Ticor Title Insurance Company pertaining to the donated properties for the donees. The donees shall

accept the state of the title presented by such commitments and the escrow will be disbursed pursuant to the understandings in this Letter, unless, within five days after receipt of the commitments, the donees, or either of them, make written objection to the title to PPG. If any objections to title are so made, it is understood that PPG will have no obligation to cure the title, but, upon refusal of either or both of the donees to accept the state of the title presented, the donation of the donated properties will not be consummated and PPG will retain title to the same.

B. In the event no objection to title is made by either or both of the donees, at the time of closing, PPG will secure, at its own cost, an owner's policy of title insurance for each of the donees, based upon the above-referenced title commitments. The amount of title insurance suggested for the properties being donated to the State of California is \$272,847. The amount of title insurance suggested for the property being donated to the County of Inyo is \$228,813. The donees hereby agree to these amounts for title insurance purposes only.

6. Costs.

A. In addition to any costs for title search and title premiums, as discussed above, PPG will pay the cost of closing, including any escrow fees imposed by Ticor Title Insurance Company.

Because the State of California has prepared the deeds to the donees at no cost to PPG, and because, pursuant to Section 11922 of the California Revenue and Taxation Code, no transfer taxes will be assessed, PPG will have no obligation to pay such charges. In addition, the State of California will arrange to have the deeds to the donees recorded at no charge to PPG.

7. Southern Pacific Transportation Company.

PPG hereby discloses to the donees that it had entered into certain leases, crossing and service agreements with the Southern Pacific Transportation Company ("SP") in connection with PPG's former operations on the donated properties. PPG further discloses that it has, or will shortly, indicate its intention to the SP to formally terminate such leases and agreements.

Pursuant to its rights, the SP may enter upon the donated properties to remove any pipelines, tracks, and other facilities formerly used by PPG as are located on or adjacent to the property or rights-of-way of the SP. The donees hereby agree to permit the SP to enter upon the donated properties for such purposes and to release PPG from all liability therefor.

8. Post Closing Obligations.

After title to the donated properties is vested in the donees, PPG will have no further obligation to either of the donees or their respective successors or assigns with regard to the donated properties by virtue of such donations except for such specific post closing responsibilities as PPG may expressly choose to assume in the deeds delivered to each donee.

<u> 264</u> <u>1339</u> The purpose of this Letter of Understanding is to establish the understandings of the parties hereto in effecting the donations. It is understood that PPG has no legal obligation to transfer title to the donated properties to the donees or either of them. Rather the parties hereto acknowledge that the donation transaction discussed in this Letter of Understanding is a donation freely made by PPG as a charitable contribution to the State of California, acting by and through the State Lands Commission, and the County of Inyo.



At the time the Letter of Understanding concerning the above donation was prepared, we had anticipated that the Southern-Pacific Railroad might request permission to enter upon the donated land for the purpose of removing certain pipeline and other improvements constructed under the Southern-Pacific right-of-way.

We now understand that the Southern-Pacific might request PPG, through its own employees, or through contractors or subcontractors, to perform this work. Accordingly, we are hereby writing to request your consent, as an amendment to the Letter of Understanding, to allow PPG, either through its own employees, or its contractors or subcontractors, to enter upon the donated lands, as necessary, to remove and/or otherwise secure the improvements travelling under and traversing the Southern-Pacific Railroad, if the Railroad should request PPG to do so.

In the event PPG, through its own employees, or through those of contractors or subcontractors, does perform these work activities, we will of course assume all responsibilities with regard to such activities.
