OTHER PERTINENT INFORMATION:

1. Lease PRC 3265.1 was originally issued to Shell Oil Company beginning April 1, 1965. Effective April 1, 1980, the lease was amended and assigned to Ron Schirmer. Commencing in June 1982,

a number of transactions occurred concerning the adjacent upland property, and the State lease was ultimately assigned to Mariner's Centre, Ltd., from Ron Schirmer, effective June 1, 1982 and approved by the State Lands Commission. Subsequent to that assignment the parcel was sold to Miller-Nahas, a California general partnership on July 15, 1983. Staff recommends approval of the assignment of the State's Lease to Miller-Nahas Partnership from Mariner's Centre Ltd., effective July 15, 1983.

- 2. It is the intention of the new owners, Miller-Nahas, to remove the Shell Gas Station, which is now closed, and the supply store, and develop the upland with a three-story mixed use retail and office building. The marine fueling dock facility, under lease by the State, will stay in operation with no changes.
- 3. This project is exempt from CEQA because it is not an activity which will have a significant environmental effect, pursuant to 14 Cal. Adm. Code 15060.
- 4. The project is situated on lands identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in a use category "C" which authorizes Multiple Use. The project as proposed will not have a significant effect upon the identified environmental values.
