portions of a porch and patio.

TERMS OF PROPOSED PERMIT:

Initial period: Ten years from June 1,

LAND DESCRIPTION

A parcel of tide and submerged land in Contra Costa County, California, in Sheep Slough adjacent to the southeastern portion of Dutra Island and west of Quimby Island; described as follows:

All that land lying immediately beneath a boat dock, gangway platform, pier, patic, gazebo, and porch as shown on Corps of Engineers Public Notice No. 8151 dated February 15, 1983 TOGETHER WITH a necessary use area extending 10 feet from the extremities of said facilities.

EXCEPTING THEREFROM any portion lying landward of the ordinary high water mark.
