AWARD OF ROYALTY OIL SALES CONTRACT, STATE OIL AND GAS LEASE PRC 425, HUNTINGTON BEACH FIELD, ORANGE COUNTY

On August 25, 1983, the Commission authorized the sale by competitive bidding of royalty oil produced from State Oil and Gas Lease PRC 425. This consists of 710 barrels per day of 21° API gravity crude oil. The royalty oil is currently being purchased under contract by Champlin Petroleum Company which will expire on December 1, 1983.

On September 13, 1983 Staff offered by competitive public bid the royalty production from State Lease PRC 425. Attached as Exhibit "A" is the list of bidders and their bonus bids in dollars per barrel above the base price. The base price is the highest price posted for oil of like gravity and quality in the Huntington Beach Field on the day of delivery by a company purchasing or paying royalties on oil in that field.

The Commission staff has reviewed the financial ability of the bidders to fulfill the obligations of the contract and their physical ability to take the oil, and has determined the highest responsible bidder which is identified on Exhibit "A". The contract, if awarded, will be for a term of eighteen months, with delivery commencing on December 1, 1983. Delivery of the oil will be by exchange agreement without any change in the existing oil production and transportation facilities. Acceptance of the bid and issuance of a sales contract is exempt from CEQA because this activity does not constitute a project.
