LETTER OF PERMISSION - SANTA CLARA VALLEY WATER DISTRICT WP 3968

PRC 3968

A LETTER OF PERMISSION WAS GRANTED TO THE SANTA CLARA VALLEY WATER DISTRICT, IN ADVANCE OF A ROUTINE PERMIT, TO IMPROVE AND CONSTRUCT LEVEE WORKS AT ALVISO, IN SANTA CLARA COUNTY. TO PROTECT THE TOWN FROM FLOODING, AS OCCURRED LAST SPRING. NORMAL PROCESSING OF A PERMIT WOULD NOT ALLOW THE PROJECT TO BE COMPLETED IN A TIMELY MANNER.

THE DISTRICT HAS APPLIED FOR A PERMIT, AND IT IS BEING PROCESSED.

THE CITY HAS CLEARANCES FROM OTHER JURISDICTIONS, AND THERE ARE NO ENVIRONMENTAL CONCERNS OVER THE PROJECT.

LETTER OF PERMISSION - OXY PETROLEUM, INC. W 23242

A LETTER OF PERMISSION WAS GRANTED TO OXY PETROLUUM, INC., TO ENTER UPON SURMERGED LAND IN BUTTE SLOUGH, SUTTER COUNTY, TO BEGIN CONSTRUCTION OF GAS PIPELINES PRECEDING ISSUANCE OF A FORMAL LEASE. THE PROJECT WAS SLATED FOR CONSTRUCTION ON SEPTEMBER 5, 1983. ALL OTHER AUTHORIZATIONS HAVE BEEN ACQUIRED, HOWEVER, THE APPLICANT WAS UNAWARE OF THE STATE LEASE REQUIREMENT.

OXY PETROLEUM, INC., HAS APPLIED FOR A RIGHT OF WAY LEASE. HOWEVER, AS A CONDITION OF RECEIVING THE LETTER OF PERMISSION, THEY HAVE AGREED TO APPLY FOR AN OIL AND GAS LEASE OR A COMPENSATORY ROYALTY AGREEMENT. THE PROCESSING
