A 0.721-acre parcel of tide and submerged
land in Santa Barbara channel near Ellwood
Pier, Santa Barbara County.

LAND USE: Installation and maintenance of one mooring
buoy.

OTHER PERTINENT INFORMATION:

1. On January 27, 1983, the State Lands Commission issued an industrial use lease to Exxon Company, U.S.A., for installation and maintenance of one mooring buoy in the Santa Barbara Channel, Santa Barbara County. The Coastal Commission hearing for a permit on the mooring buoy was held August 10, 1983. As a condition of the Coastal Commission permit, Exxon is required to change the location of the mooring buoy for safety purposes. The new location will minimize conflicts with commercial fishing operations, mariculture operations, other oil company operations, and damage to adjacent kelp beds. Exxon has submitted to staff a new location description for the buoy placement which has been approved by the Coastal Commission.
2. This activity is exempt from CEQA because it is not a project having a significant environmental effect pursuant to 14 Cal. Adm. Code, Div. 6, Sec. 15061(b-3).
3. The project is situated on lands identified as possessing significant environmental values pursuant to P.R.C. 6370.1 and is classified in a use category "B" which authorizes Limited Use. The project as proposed will not have a significant effect upon the identified environmental values.

2. AUTHORIZE ISSUANCE TO EXXON COMPANY, U.S.A. OF AN AMENDMENT WHICH CHANGES THE PREVIOUSLY APPROVED LOCATION OF A PROPOSED BUOY PLACEMENT UNDER LEASE PRC 6371.1 TO A LOCATION ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF; ALL OTHER TERMS AND CONDITIONS OF LEASE PRC 6371.1 SHALL REMAIN IN FULL FORCE AND EFFECT. THE EFFECTIVE DATE OF THIS AMENDMENT IS SEPTEMBER 1, 1983.

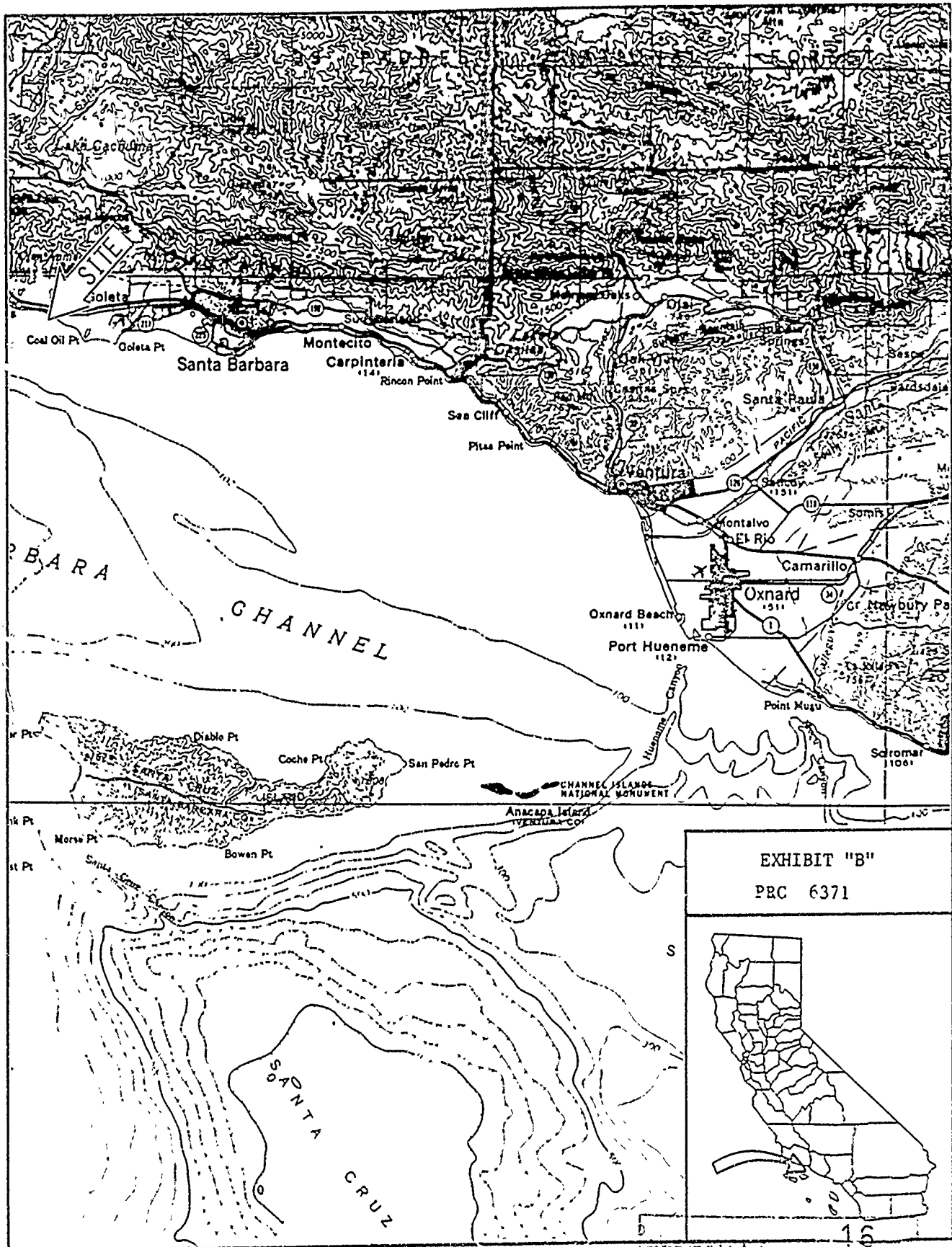
