AREA, TYPE LAND AND LOCATION:
A 0.101-acre parcel of tide and submerged land located in Big River and Albion River, Mendocino County.

LAND USE: Installation and maintenance of a communications (cable-television) cable at both locations.

TERMS OF ORIGINAL LEASE:
Initial period: 15 years from December 1, 1978.

Surety bond: \$2,000.

Public liability insurance: \$300,000 combined single limit coverage.

Consideration: \$100 per annum; five-year rent review.

LAND DESCRIPTION

PRC 5592.1

PARCEL 1

A 10 foot wide strip of land in the bed of Big River, Mendocino County, California, and lying 5 feet on each side of the following described centerline:

COMMENCING at the southeast corner of Section 30, T17N, R17W, MDM; thence N 58° 17' 20" W 1173.86 feet; thence S 61° 12' 37" E 120 feet to the TRUE POINT OF BEGINNING: thence along a 1620 foot radius curve concave to the west, tangent to N 28° 47' 23" E and through a central angle of 21° 13' 14" an arc distance of 600 feet and the end of the herein described centerline.

EXCEPTING THEREFROM any portion lying landward of the ordinary high water marks of Big River.

PARCEL 2

A 10 foot wide strip of land in the bed of Albion River, Mendocino County, California, and lying 5 feet on each side of the following described centerline:

COMMENCING at the intersection of the centerline of and the south abutment of the state highway that crosses said river within Section 28, T16N, R17W, MDM; thence S 78° 31' 30" E 15.0 feet to the TRUE POINT OF BEGINNING: thence N 11° 28' 30" E 600 feet and the end of the herein described centerline.

EXCEPTING THEREFROM any portion lying landward of the ordinary high water marks of Albion River.

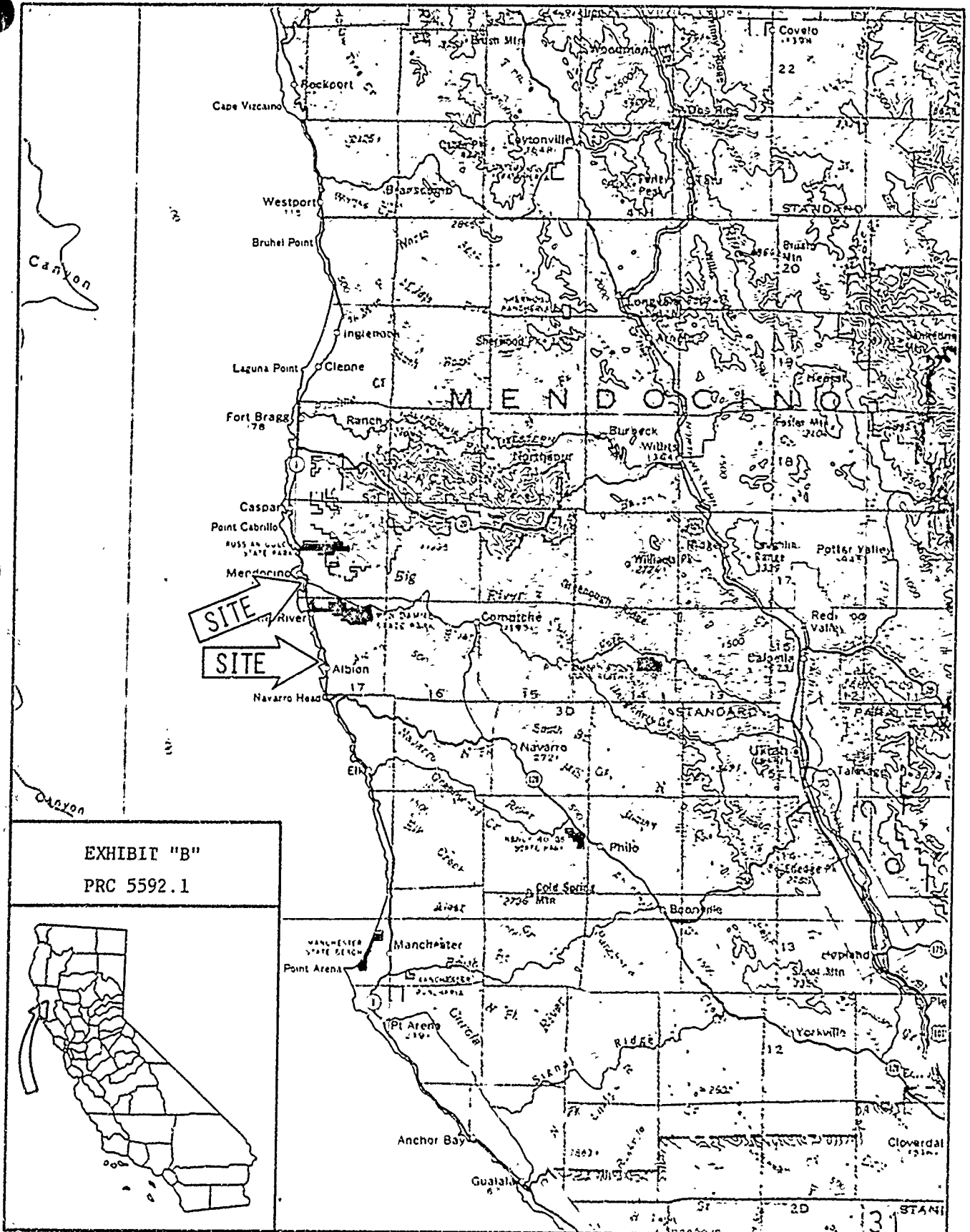
