OTHER PERTINENT INFORMATION:

1. An EIR is not required. This transaction is within the purview of 14 Cal. Adm. Code, Div. 6, Section 15301, which exempts existing facilities and topographic features.
2. The project is situated on lands not identified as possessing significant environmental values pursuant to P.R.C. 6370.1.
3. In compliance with Section 6373 of the P.R.C., a General Plan has been prepared and filed with the Legislature.
4. A staff review shows that the land is not suitable for cultivation and therefore may be sold under the rules and regulations and at a price fixed by the Commission.
5. Staff has reviewed the appraisal of the land included in the right-of-way, and the value of the timber cleared in construction and concurs in the estimated fair market value of \$1,000.

IT IS RECOMMENDED THAT THE COMMISSION:

1. DETERMINE THAT AN ENVIRONMENTAL DOCUMENT HAS NOT BEEN PREPARED FOR THIS ACTIVITY AS SUCH DOCUMENT IS NOT REQUIRED UNDER THE PROVISIONS OF P.R.C. 21084, 14 CAL. ADM. CODE 15300 ET SEQ., AND 2 CAL. ADM. CODE 2905.
2. FIND THAT A GENERAL PLAN FOR THE USE OF THE SUBJECT PROPERTY HAS BEEN PREPARED BY THE COMMISSION'S STAFF AND FILED WITH THE LEGISLATURE, PURSUANT TO P.R.C. 6373.
3. FIND THAT THIS ACTIVITY IS SITUATED ON LAND NOT IDENTIFIED AS POSSESSING SIGNIFICANT ENVIRONMENTAL VALUES.
4. FIND THAT THE STATE SCHOOL LAND, DESCRIBED IN EXHIBIT "A" ATTACHED HERETO, IS NOT SUITABLE FOR CULTIVATION WITHOUT ARTIFICIAL IRRIGATION.

5. AUTHORIZE THE SALE, WITHOUT ADVERTISING, OF THE TRESPASSED TIMBER AND A PERPETUAL EASEMENT OVER THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF, TO THE UNITED STATES OF AMERICA; SUBJECT TO ALL STATUTORY AND CONSTITUTIONAL RESERVATIONS, INCLUDING RESERVATIONS OF ALL GEOTHERMAL AND MINERAL RESOURCES FOR \$1,000 CASH.

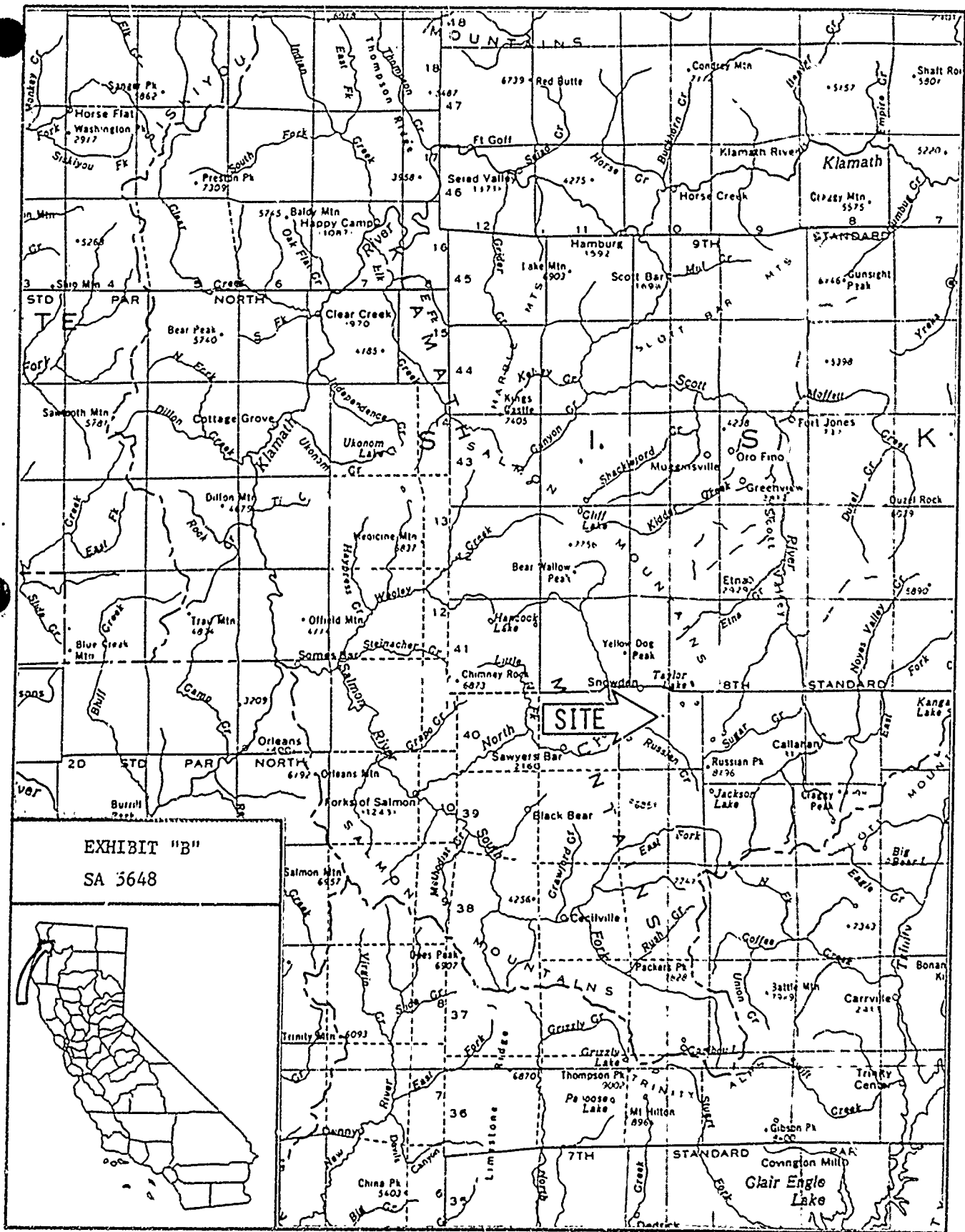

GENERAL PLAN

SA 5648

The U.S. Forest Service has applied to the State Lands Commission to purchase a parcel of State land located in the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 16, T40N, R10W, MDM, in Siskiyou County.

The application involves acquisition of a 66-foot wide, .19 mile long right-of-way on an existing road, designated Forest Service Road 40N54 (South Russian Road), primarily used for timber access. It is also open to public uses, including recreation and wood gathering. The Forest Service intends to access Klamath National Forest lands east of the State parcel via continuation of Road 40N54.

This General Plan is submitted in conformance with Section 6373 of the Public Resources Code.
