AWARD OF ROYALTY OIL SALES CONTRACT, STATE OIL AND GAS LEASE PRC 3120, SOUTH ELWOOD OFFSHORE FIELD, SANTA BARBARA COUNTY

On October 27, 1983 the Commission authorized the competitive bid sale of royalty oil produced from State Oil and Gas Lease PRC 3120. The royalty oil is currently being purchased by U.S. Oil and Refining Company under a contract which provides for a bonus of \$0.69 per barrel above the Base Price and will expire on July 1, 1984. The State's share of royalty oil produced from State Lease PRC 3120 is approximately 1,500 barrals per day of 20.0 API gravity crude oil.

On October 31, 1983 the staff offered by competitive public bid the royalty production from State Lease PRC 3120. Bids were received and opened on November 15, 1983. Attached as Exhibit "A" is a list of the bidders and their bonus bids in dollars per barrel above the base price. The base price is the higest price posted for oil of like gravity and quality in the Scoth Elwood Offshore Field on the day of delivery.

The Commission staff has reviewed the financial ability of the bidders to fulfill the obligations of the contract and their physical ability to take the oil, and has determined the highest responsible bidder identified on Exhibit "A". The contract, if awarded, will be for a term of eighteen months, with delivery commencing on July 1, 1984. The highest responsible bidder will take delivery and transport the oil without any change in the existing oil production and transportation facilities. All royalty oil will be transported from the Ellwood marine terminal by Public Service Marine, Inc. using the barge. "Jovalar" which meets the requirements of Sanca Barbara County Ordinance No. 2919.
