AUTHORIZATION OF THE EXECUTION AND  
RECORDATION OF AN EXCHANGE AGREEMENT AMONG THE  
CITY OF FOSTER CITY, THE  
ESTERO MUNICIPAL IMPROVEMENT DISTRICT, AND THE COMMISSION

At its March 24, 1983, meeting, the State Lands Commission authorized the execution and recordation of an exchange agreement among the City of Foster City, the Estero Municipal Improvement District, and this Commission. The property subject to the agreement is shown in its general location on Exhibit "B" to this Calendar Item. Exhibit "B" is attached to this item and incorporated by reference.

This Commission's March 1983 approval set January 1, 1984, as the final date for recordation of this agreement. It now appears that the original copy of the agreement has vanished between the offices of Estero Municipal Improvement District and the City of San Mateo.

It is requested that the Commission grant a six-month extension of the time to record the agreement so that a new original agreement can be prepared for execution.

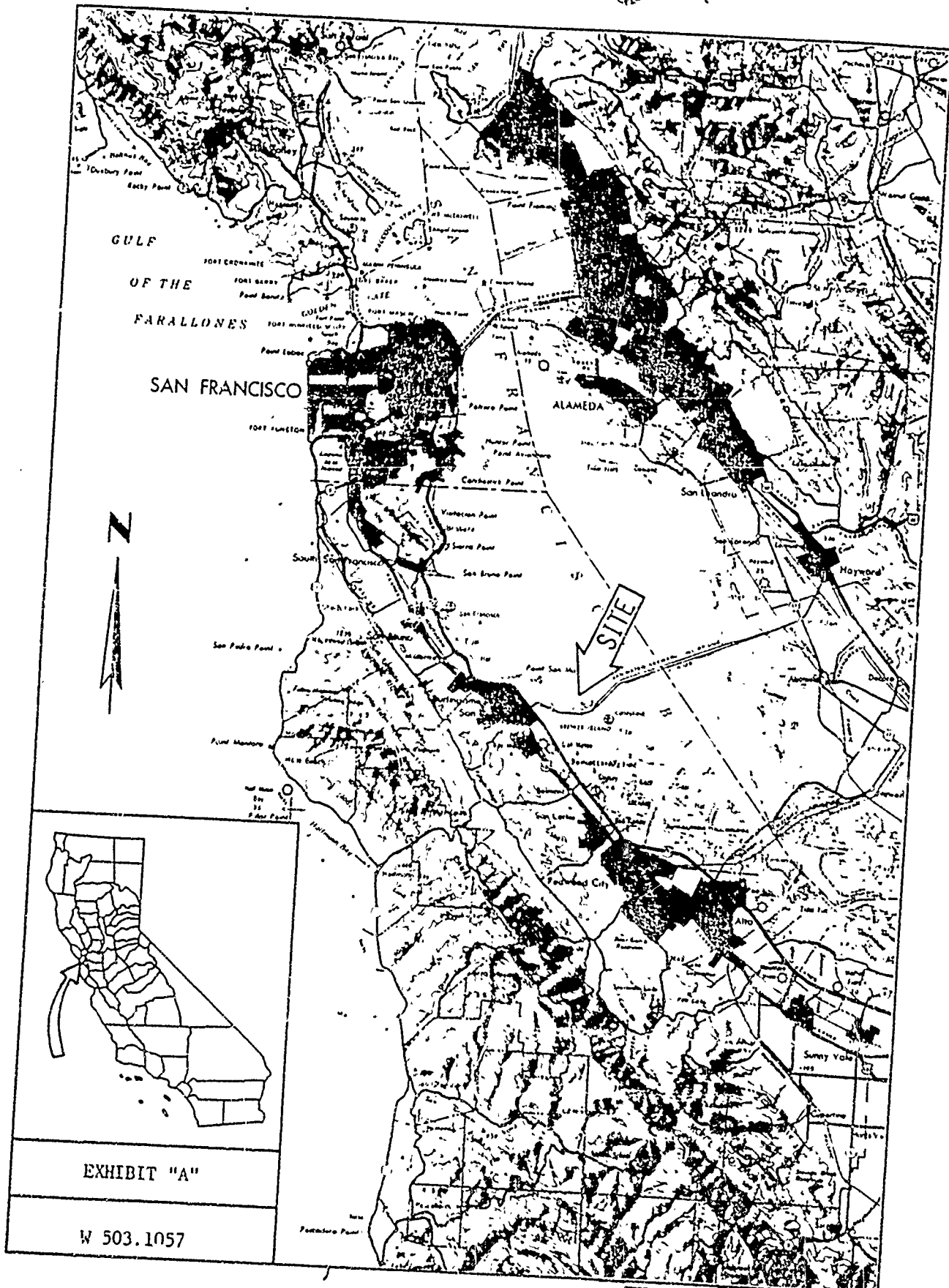
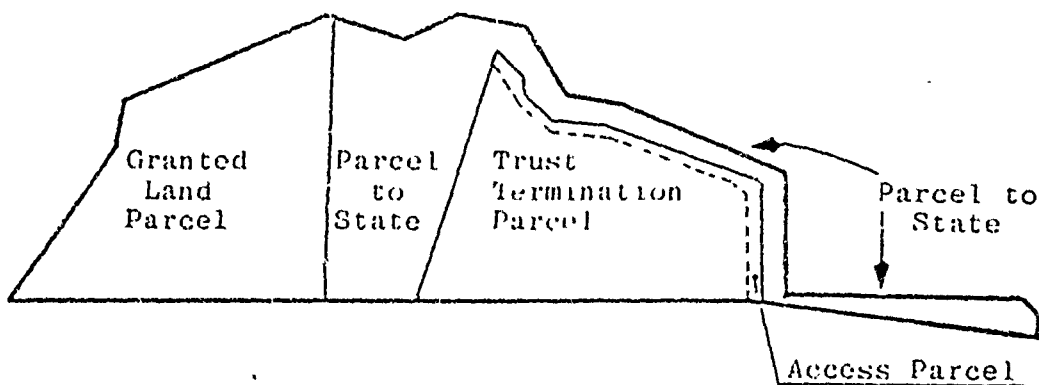

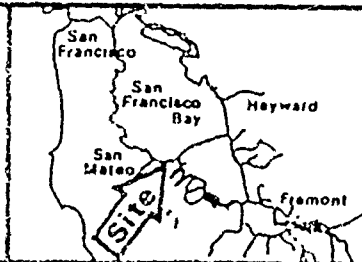
