Special:

1. The permit is conditioned on permittee's conformance with the Tahoe Regional Planning Agency's Shorezone Ordinance.
2. The permit is conditioned on the authorization and consent of Forest Homes of Cedar Flat, Inc., for any of the subject facilities found to be on or adjacent to their lands.
3. The permit is entered into by all parties without prejudice to their respective claims of boundary.

CONSIDERATION: \$70 per annum with the State reserving the right to fix a different rental on each fifth anniversary of the permit.

Pursuant to 2 Cal. Adm. Code 2503.

OTHER PERTINENT INFORMATION:

1. This transaction is occasioned by the conveyance of Assignor's interest in the nearby residential property to Assignee. Applicant is not the owner of the upland.
2. This transaction is exempt from CEQA because it is not a project pursuant to P.R.C. 21065, 14 Cal. Adm. Code 15378.
3. This project is situated on lands identified as possessing significant environmental values pursuant to P.R.C. 6370.1 and is classified in a use category "B" which authorizes Limited Use. The project as proposed will not have a significant effect upon the identified environmental values.

2. APPROVE, EFFECTIVE FEBRUARY 23, 1984, THE ASSIGNMENT OF GENERAL PERMIT - RECREATIONAL USE, PRC 4467.1, COVERING MAINTENANCE OF A PIER UTILIZED FOR RECREATIONAL BOATING, FROM LEWIS A. GRESS AND CAROLE A. GRESS TO DENNIS GRIMSMAN AND DIANE GRIMSMAN.

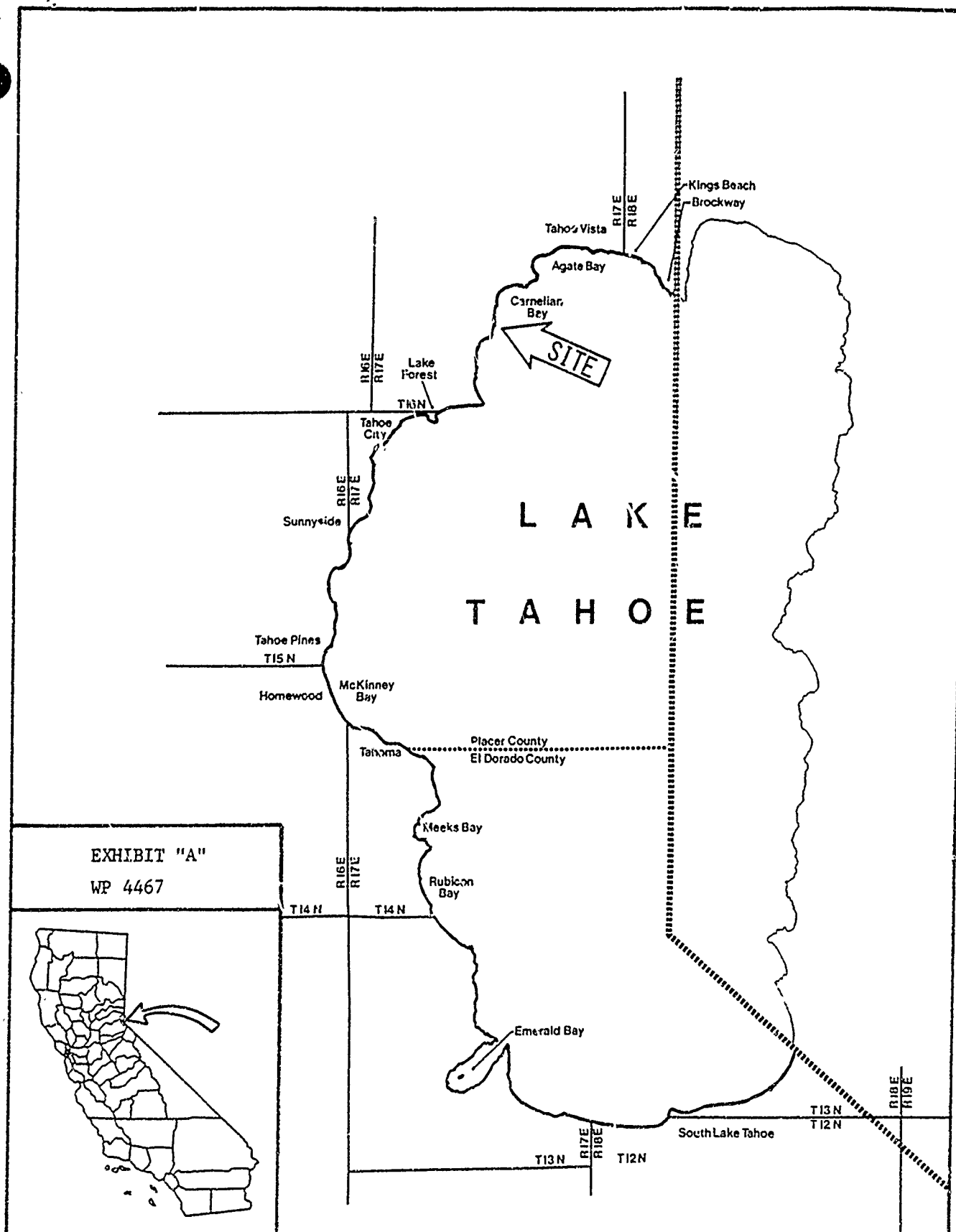
