AMENUMENT OF GENERAL LEASE - COMMERCIAL USE

APPLICANT:

La Reserve, Inc., d.b.a. Aipine Marina P.O. Box 7787 Incline Village, Levada 89450

DACKGROUND INFORMATION:

On November 21, 1983, the State Lands Commission approved the issuance of a 20-year General Lease - Commercial Use to La Reserve, Inc., d.b.a. Alpine Marina with an effective date of May 6, 1983, for the operation of a commercial marina on a 1.643-acre parcet of submerged land located in Lake Tahoe, Placer County.

The lease document provided for the Lessee's right of renewal for an additional lease term of not more than nine (9) years, provided that Lessee shall give written notice of the exercise of such right to Lesser at least six (6) months prior to the expiration of the lease term.

This information was inadvertently omitted from the Calendar Item which was approved by the Commission on November 21, 1983 (Hinute Item No. 11).


