OTHER PERTINENT INFORMATION:

1. Staff recommends approval of a license to the applicant to enter onto the Pacific Coast Beaches below mean high tide in Humboldt and Del Norte Counties, for collection of driftwood and redwood to create for sale furniture and gift items. This license will give the applicant non-exclusive use of the lands as described in Exhibit "A" for the stated purpose only.

The applicant requested the license because the local law enforcement agencies strictly enforce the law covering transportation of Forest products pursuant to Section 384.5 of the California State Penal Code. As a condition of the license, the applicant agrees to use only public access designated as such to gain entrance to State lands.

2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorical exempt project. The project is exempt under Section 15304, Minor Alteration to Land and Water, 14 Cal. Adm. Code.

Authority: P.R.C. 21084 and 14 Cal. Adm. Code 15300.

3. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.
