DREDGING PERMIT

APPLICANT:

San Mateo County Harbor District

#1 Johnson Pier

Half Moon Bay, Colifornia 94019

AREA, TYPE LAND AND LOCATION:

Tide and submerged lands granted to the San Mateo County Harbor District with minerals reserved to the State within the grant area of the Harbor, San Mateo Count, California.

LAND USE:

Dredge up to a total of 30,000 cubic yards of sediment to deepen the harbor to -10 feet MLLW.

Spoils taken from the harbor will be transferred to Miramar Beach east of the harbor and to a small site at the harbor as fill for a parking lot on publicly owned lands.

TERMS OF PROPOSED PERMIT:

Initial period: One year from March 1, 1984.

CONSIDERATION:

No royalty to be charged for spoils placed on publicly owned lands and beaches. A royalty of \$0.25 per cubic yard will be charged for spoils placed on private property or sold for

commercial benefit.

PREREQUISITE TERMS, FEES AND EXPENSES:

Filing fee has been received.

OTHER PERTINENT INFORMATION:

- 1. San Mateo County Harbor District, through its agent, Winzler and Kelley, Engineers, has applied for a dredging permit to remove up to 30,000 cubic yards of material from Pillar Point Harbor. The material will be deposited on Miramar Beach, east of the Harbor and at a parking lot site at the harbor.
- 2. This activity involves lands identified as possessing significant environmental values pursuant to PRC 6370.1, et seq. Based upon the staff's consultation with the persons rominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.
- 3. Pursuant to the Commission's delegation of authority, and the State CEQA Guidelines (14 Cal. Adm. Code 15061) the staff has determined the project is categorically exempt from the requirements of the CEQA under Class 4(g) maintenance dredging with spoils deposition in areas approved by all applicable regulatory agencies, 14 Cal. Adm. Code 15304.

- FIND THAT THIS ACTIVITY, AS PROPOSED, IS CONSISTENT WITH THE USE CLASSIFICATION DESIGNATED FOR THE LAND PURSUANT TO PRC 6370, ET SEQ.
- AUTHORIZE THE STAFF TO ISSUE TO THE SAN MATEO COUNTY HARBOR DISTRICT THE DRENGING PERMIT ON FILE IN THE OFFICES OF THE COMMISSION. SAID PERMISSION SHALL BE ISSUED IN CONSIDERATION OF NO ROYALTY TO BE CHARGED FOR MATERIALS PLACED ON PUBLICLY OWNED LANDS AND A ROYALTY OF \$0.25 PER CUBIC YARD FOR SPOILS PLACED ON PRIVATE PROPERTY OR SOLD FOR COMMERCIAL BENEFIT SAID PERMIT SHALL BE FOR A PERIOD OF ONE YEAR FROM MARCH 1. 1984, AND SHALL ALLOW FOR A MAXIMUM OF 30,000 CUBIC YARDS OF SAND, SILT AND GRAVEL EXCLUDING ALL OTHER MINERALS, INCLUDING BUT NOT LIMITED TO OIL, GAS AND GEOTHERMAL FROM AN AREA OF TIDE AND SUBMERGED LANDS GRANTED TO SAN MATEO COUNTY HARBOR DISTRICT WITH MINERALS RESERVED TO THE STATE IN PILLAR POINT HARBOR, COUNTY OF SAN MATEO; SAID AREA AS DESCRIBED IN EXHIBITS "A" AND "B" ATTACHED HERETO AND BY THIS REFERENCE EXPRESSLY MADE A PART HEREOF; MATERIALS DREDGED SHALL BE DEPOSITED ON PUBLICLY OWNED DISPOSAL SITES APPROVED BY ALL APPLICABLE REGULATORY AGENCIES. THE COMPLETE PERMIT IS CONTAINED IN FILE W 23305, LOCATED IN THE COMMISSION OFFICES.
