DEFERMENT OF DRILLING REQUIREMENTS, STATE OIL AND GAS LEASE PRC 2879

State Oil and Gas Lease PRC 2879 was issued on April 26, 1962, and contains approximately 5,653 acres of tidelands lying south and offshore Point Conception in Santa Barbara County. It is the westernmost offshore State Oil and Gas Lease in the Santa Barbara Channel and adjacent to the proposed Point Conception State lease area.

SUMMARY:

On November 23, 1982, the State Lands Commission granted Union a deferment of the drilling requirements of State Oil and Gas Lease PRC 2879 until June 1, 1983. Commencing on March 23, 1983, Union drilled 18-6 and 18-6 No. 1 redrill. Both of these exploratory wells were tested extensively and the redrill was finally abandoned on June 17, 1983. In October 1983, the Commission granted to Union a deferment from October 17, 1983 through April 16, 1984.

In a letter dated March 9, 1984, Union stated that a decision to prepare a Development Plan had been made and has requested a 12-month deferment of the drilling obligation. Staff recommends a six-month deferment, until October 25, 1984, conditioned on Union submitting a development plan prior to that time.
