DENIAL OF APPLICATION

Chapter 1200, Statutes of 1977 (AB 884), requires State agencies to compile lists of criteria specifying the detailed application information required of applicants for development projects. Accordingly, the State Lands Commission adopted its application criteria through Calendar Item 2 at its April 27, 1978, meeting.

Under Chapter 1200, Statutes of 1977 (AB 884), once an application has been accepted as complete, the Commission must act on the application within specified time periods. Failure to act within the time allowed, either by approving or denying the project, could result in approval of the project (by operation of law).

Therefore, pursuant to Chapter 1200, Statutes of 1977, the following application for the State Lands Commission lease is submitted for denial. This application should be denied without prejudice, because the applicant placed two existing mooring buoys and anchors in a designated fish habitat area without first receiving the prior approval of the Department of Fish and Game and other commenting agencies. The Department of Fish and Game and staff recommend denial of the application.

If the applicant is later able to eliminate or mitigate the negative environmental impacts relative to the project site, he may reapply for project approval. The planned project covered the amendment of applicant's lease, PRC 5354.1, to include the two existing buoys and anchors.
